#### Checklist for Candidates

##### Appearing for MAH-LL.B-5 Yrs. & LL.B.-3 Yrs. CET-2017

CET CELL is conducting On-Line CET for MAH-LL.B-5 Yrs. On Saturday 20<sup>th</sup> May 2017 and for LL.B.-3 Yrs. On Sunday 21<sup>st</sup> May 2017.

CET CELL is giving the check list for the candidates to verify the following important things in their own interest:-

1. Have you downloaded your Application form and e-receipt from Application Link?
  2. Have you downloaded your Hall Ticket from the Hall Ticket link?
  3. Have you verified that you are in possession of the one of Original Photo Identity Proofs mentioned in the Hall Ticket/Information Brochure?
  4. If there is change of name, are you in possession of Government Gazette, Marriage Certificate or Original Affidavit?
  5. Have you verified the Centre/Venue address?
  6. Have you tried the mock test link provided to give you a feel of On Line Examination?
  7. Have you made a note that you need to carry Hall Ticket with photo pasted on it, Original Valid photo identity proof mentioned in Hall Ticket/Information Brochure and Change of Name Proof, if applicable, to the CET Examination Centre.
  8. Lastly, have made a note that you have to reach the specified examination centre well before the reporting time on specified date mentioned in your Hall Ticket?
- If your answers to all above questions are "YES", then you are ready for the CET Examination.

##### On Line CET Examination:

##### Instructions to Candidates.

1) All candidates who have successfully registered for MAH- .LL.B-5 Yrs CET 2017 / MAH- .LL.B-3 Yrs CET 2017 and filled in the form and made the successful on line payment are directed to log in by clicking the MAH- .LL.B-5 Yrs / MAH- .LL.B-3 Yrs., CET Application Form Link available on [www.dhepune.gov.in](http://www.dhepune.gov.in) and log in by using Registration No and Password and click on **Application Print and E-receipt print** and take a print out of the Application Form and E-receipt and keep with them. Candidates will be able to print their applications upto 21<sup>th</sup> May 2017. This link will be deactivated thereafter. No request for this will be entertained afterwards.

2) The link for downloading the Hall Ticket is available on [www.dhepune.gov.in](http://www.dhepune.gov.in) and [www.mahacet.org](http://www.mahacet.org). Candidates are advised to download the hall ticket by clicking on the link. The candidates are advised to take a print out of the Hall Ticket back to back and not on two separate sheets.

3) The candidates are advised to read the instructions on the Hall ticket carefully and follow them in their own interest.

4) The Hall Ticket contains following details on it: i) Roll No of the Candidate ii) Registration No of the Candidate iii) Log in ID and Password required for logging in to on line CET,

5) Candidates are advised to affix the latest photo on the Hall Ticket.

6) Candidates are advised to carry any valid original Identity Proofs mentioned in the Information Brochure and Hall Ticket. Candidates should remember that Colour copy / Soft Copy of the Photo Identity Proof will not be accepted at any cost.

7) If there is a change in Name Candidate is advised to bring Government Gazette, Marriage Registration, or Original Affidavit to that effect.

8) Candidates using Scribe are directed to download the scribe declaration form and fill it and affix the photo of the scribe. Bringing own scribe is the responsibility of the Candidate.

9) Candidates who sought extra time should possess relevant disability certificate signed by Competent Authority.

10) Candidates are advised to report to the CET CENTRE/Venue much before the reporting time. Candidates reporting to CET CENTRE/Venue after the reporting time will not be allowed to appear for the examination. Such candidates will not be adjusted in the next session. Candidates are directed to note this fact and reach the Centre much before the reporting time.

11) Candidates who have sought centers where travelling is required to other city, should preferably reach the centre city a day ahead of the examination and verify the venue address in their own interest. Candidates should also take into consideration Traffic, Mega Block, curtailment of services and ensure reaching the CET Examination Venue much before the reporting time.
