About the Tournament:

The ILS Debating Society is organizing its 11th edition of the annual three-day national parliamentary debate, namely Justice V.M. Tarkunde National Parliamentary Debate. Every year we conduct this debate in the honor of the eminent Justice V.M Tarkunde. It follows the 3 on 3 **Asians Parliamentary Debating format**. It is a semi-open tournament and institutional cross teams are permitted.

For the first two days, i.e., 20 and 21 of January, preliminary rounds be conducted and post break rounds will take place on 22 of January, 2023.

1. **Registration Fee for participants is INR 1584/- (inclusive of GST) without accommodation.**
2. **The accommodation fee for participants is INR 1050/- (inclusive of GST). The accommodation will be provided for 2 nights and 2 days.**
