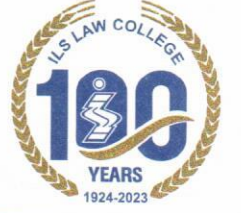

# INTERNAL EXAMINATIONS - III, IV and V B.A. LL.B. & III LL.B.- 2022-23

Students of III-V B.A. LL.B. and III LL.B. are hereby notified that the internal examinations for the core subjects of the first term of academic year 2022-23 shall commence from 19 September 2022. The exam will be conducted in the pattern of continuous evaluation, with the following changes:

1. The viva voce examinations are scheduled on every Monday of the week, instead of Saturday, starting from 19 September.
2. The syllabus for the same will be declared on the preceding Wednesday, in class, by the concerned teacher.
3. Every Monday, the batch of students scheduled for viva consists of 12-13 students.
4. There will be no extension of the timetable. The class will be 48 minutes long, instead of one hour.
5. Written test will be taken after the end of regular teaching for this semester, and the schedule for that will be intimated later.

Students should take note of the following:
