Central Government and is not available in India. This censorship has extended to the deletion of tweets and social media posts criticizing the ban.

X, a liberal journalist working with a prominent conservative news agency, has come into a copy of this documentary and can release this to the Indian public. However, this cannot be done anonymously.

THP, as X, would release the documentary.
