**ADMISSION TO FIRST YEAR OF Five Year Integrated Full Time Regular Under-Graduate Degree Course  
In Law, Viz. LL.B 5 YEAR FOR THE ACADEMIC YEAR 2016-2017**

As per the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Competent Authority is conducting CET [MAH-LL.B 5 YEAR CET-2016] for admission to the First Year of Five Year Integrated Full Time Regular Under-Graduate Degree Course In Law Viz. LL.B 5 YEAR.

The Online Applications are invited for CET for ADMISSION TO FIRST YEAR OF Five Year Integrated Full Time Regular Under-Graduate Degree Course In Law, Viz. LL.B 5 YEAR in the Government, Aided and Unaided Institutes in the Maharashtra State.

**Eligibility Criteria for appearing to MAH-LL.B 5 YEAR CET-2016:**

**The candidate should be an Indian Citizen. The Candidate belonging to the type [NRI, PIO, OCI and Foreign National Students] with following Academic Eligibility is not required to appear for CET Examination. They must apply only for CAP rounds.**

(a) An applicant who have successfully completed Senior Secondary School course (+2) or equivalent (such as 11+1, A level in Senior secondary School Leaving Certificate course) from a recognized university of India or outside or from Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course Examination, with minimum of 45% marks in aggregate (candidate belonging to SC/ ST Category with minimum 40% marks)

(b) The applicants who have obtained +2 Higher Secondary Pass certificate or First Degree Certificate after processing studies in distance or correspondence method is eligible for the course.

Provided that, the applicants who have obtained 10+2 through open university system directly without having any basic qualification are not eligible

Further provided that, applicants who have obtained 10<sup>th</sup> std./Secondary Schooling Certificate Examination, in a single sitting examination without having basic qualification (1<sup>st</sup> to 9<sup>th</sup> standard of schooling) is not eligible.

Further provided that, the candidates who are appearing/appeared for the qualifying examination (regular examination of that academic year) are also eligible to apply for the Entrance Examination. Such candidate will be eligible for admission only if they produce the proof of qualifying examination and the mark lists of all parts of qualifying examination at the time of admission.

There is no Upper age limit for admission to 5 year's LL.B Course.

**Instructions to Candidates desiring Registration for MAH-LL.B 5 YEAR CET-2016:**

1. **MAH-LL.B 5 YEAR CET-2016** shall be conducted only in the **On-Line Mode** in **Multiple Sessions** if required, by Competent Authority, using standardized equi-percentile method, for equating scores across sessions in specified centers within and outside Maharashtra.
2. Aspiring candidates should note that, the tests are not disclosed to anybody else other than the candidates only during the examination session. The Test Papers are also not shared with anybody even after the Examination.
3. The CET comprises multiple choice objective type questions in the areas of (i) Legal Aptitude and Legal Reasoning (40), (ii) General Knowledge including Current Affairs (30), (iii) Logical and Analytical Reasoning (40), (iv) English (30), (v) Basic Mathematics (10) [Total 150 marks]. There would be 150

questions to be answered in a total time of Two hours (i.e. One Hundred and Twenty minutes). Medium of Question Papers will be English and Marathi.

4. There is no Negative marking for this CET.
5. It is mandatory for all aspiring candidates to **Register & Confirm** the Online Application Form for **MAH-LL.B 5 YEAR CET-2016** at <http://www.dhepune.gov.in> and at <http://www.mahacet.org>
6. Application form processing fees as stated below is to be paid through Online system only by Internet Payment, Credit Card/ Debit Card [ Rupay/Visa/Master Card/Maestro], payment gateway for which the service charges are to be paid by the candidate, as per rules of the payment gateway, shall be applicable in addition to the application form processing fees. No other mode of payment shall be permitted.

For Open Category Candidates from Maharashtra State, Outside Maharashtra State (OMS), J & K Migrant candidates	<b>Rs. 650/-</b>
For Candidates of Backward Class Categories [SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC] belonging to Maharashtra State only.	<b>Rs. 350/-</b>

7. Applications sent by Post/Courier etc., will be rejected and no communication in this regard will be made.
8. It should be noted that no documents are required to be submitted at this stage. Candidates are advised to keep the necessary documents ready at the time of Document verification stage at the time of Admission as per the notified schedule.
9. The candidates belonging to SC, VJ/DT (NT (A)), NT (B), NT(C), NT (D), OBC and SBC categories should produce "Caste Certificate" issued by Competent Authority and the Candidate belonging to ST category should submit "Tribe Validity Certificate" issued by Scrutiny Committee of Tribal Department along with Caste Certificate and candidate excepting SC, ST should submit valid Non Creamy Layer certificate at the time of verification of Admission.
