The institution is bound by the syllabus prescribed by the University. No change in the syllabus has been made. The Indian Law Society runs various self-financed diplomas and certificate courses especially for ILS Law college students and others in different areas of law. These courses are designed for students as well as practioners and as such reflect theoretical and practical exigencies of the relevant subject. With changing legislations, newly introduced amendments and a varying national and international landscape, the syllabus of these diplomas and courses is updated from time to time. Particularly, major amendments in laws such as The Companies Act 1956, requires a major overhaul of the concerned syllabus. Further, a meeting of the faculty and experts is conducted to ensure that the syllabus remains relevant in the light of all these developments.

Various innovative methods of teaching and learning are adopted by the faculty to increase students participation in classrooms like student teacher seminars, class presentations by the students, case study method etc. Effective use of information and communication technology is made. Use of power point, screening of movies are done followed by an open house debate. In addition remedial teaching course in English is conducted. Various other activities and orientations are conducted to develop advocacy skills. Other activities and cells are working in specialized areas of law and to cover issues which are not covered in regular curricular. Experts are called to interact with the students. Quizzes and debates are conducted in the classroom throughout the year to enhance conceptual clarity and develop a keen thinking. Expert faculty is invited from time to time to share their domain knowledge.

11. Workshop on Sex and Sexuality by Samapathik Trust was on 2nd March 2015.



#### 7. Innovations and Best Practices

## 7.1 Innovations introduced during this academic year which have created a positive impact on the functioning of the institution. Give details.

The Women's Studies Centre and Gender Studies Cell activities are as follows. The Cell undertook research and documentation projects which are :

#### • Judicial response to mental illness in matrimonial disputes:

The Women's Studies Centre, jointly with Centre for Mental Health Law and Policy completed the research project that analysed the legislative and judicial response to mental illness as a ground for matrimonial remedies under various marriage laws in India. Judgments of the Supreme Court and High Courts were compiled. More in-depth data was collected from the Family Court of Pune.

What emerges out of the analysis is the need for standardized guidelines for lower courts on what constitutes adequate medical proof of mental illness when hearing a petition related to nullity or divorce under the Hindu Marriage Act (HMA). The study also reviewed section 5(ii) of HMA that contributes to conceptual confusion and is reflected in judgments. A paper based on this study was published in 'Indian Journal of Medical Ethics' 2014.

#### • Guidebooks on the MTP and PCPNDT Acts:

On request of 'Pratigya – a Campaign for Gender Equality and Safe Abortion'; the Centre undertook to write simplified versions of two laws – The Medical Termination of Pregnancy Act, 1971; and The Pre-conception and Pre-natal Diagnostic Techniques (Prohibition of Sex

Selection) Act, 1994. The work on this project is in progress and would be completed in the next academic year.

### Workshop on domestic violence and mental health

This was a two and half days workshop held from: 28th to 30th Jan 2015 at YMCA, Pune

Participants: In all18 men and women who practice in the field as counsellors to women facing domestic violence and working with grass-root NGOs participated in the workshops. The NGOs were partners of the international NGO SwissAid, India,that provides financial and other support to them.

The purpose of the workshop was to enable the counsellors to understand the psychological dynamics and the status of mental health of the domestic violence survivor, and address them in counselling. Such inputs would enhance the quality of counselling and make it more effective.

A more in-depth training in the counselling process, deeper understanding of mental health and various kinds of mental disorders, and helping counsellors apply knowledge to practice emerged as further training needs.

## • UGC sponsored 'Refresher Course' on 'Integrating Gender in Legal and Social Science Pedagogy'

The refresher course was conducted from 17th Sept to 7th Oct 2015 (21 days) at the Conference Hall ILS Law College, Pune

No. of Participants that attended: In all 21 participants – 10 women and 11 men – who are law and social science teaching faculty in various colleges, attended the course.

7.3 Give two Best Practices of the institution (please see the format in the NAAC Self-study Manuals)

Title of the Best Practices: Diploma in Competition Laws

#### Its main objectives:

1. To promote confidence, poise, writing skills, critical thinking skills, and increase proficiency in basic skills such as reading, analyzing and reasoning.

- 2. To give students a better understanding of the anti-trust laws and its developing jurisprudence in India.
- 3. To help students learn the market system and legal nuances involved in it.
- 4. To help students learn the new economic regulatory architecture.

## The Context:

With the growing role of Competition Commission of India (CCI) in competition advocacy and market facilitation for all, need was felt to facilitate understanding of legal nuances of market competition by the students and create awareness among them about the industry practices in pursuance of the competition. To serve the aforementioned purposes, this course was introduced by the College. Competition and Anti-Trust Law Practice are growing and the area as a practice is expanding, the same has not been introduced as a subject in the law course. Hence it was required to offer this.

### The practice:

The College being one of the 'Knowledge Partners of the Competition Commission of India' is committed to the cause of competition advocacy in India. In pursuance of this objective, the College launched the Diploma Course in Competition Law for students and professionals under the banner of the Indian Law Society, the parent body of the College. The course was designed by Shri. Naval Chopra, Partner, Amarchand & Mangaldas Suresh A Shroff (AMSS) & Co., a leading competition practitioner in the country and other leading global practitioners and academicians. The pedagogy involved was unique and had an effect of imprinting the provisions on the minds of the students. A text book on Competition Law by Prof. Richard Whish and Dr. David Bailey by Oxford Publications is provided to all the students enrolled for this course. Both European and Indian Judicial Precedents are used to teach the subject along with established theories of Economics. Senior Advisors, Senior Associates, Principal Associate and Partners of AMSS and Shearman and Sterling LLP teach as a faculty of this course. Socratic method of teaching which shapes the views of the students on the subject through a dialogue between the teacher and the student and through a continual probing of factual situations is used while teaching.

#### **Brief Overview of the Course:**

The Diploma course was inaugurated on 8th August 2014 by Shri. Ashok Chawla, Chairman, Competition Commission of India. The course stretched over a period of 40 teaching hours.

Three students with top grades i.e. Grade A were offered an internship with the Competition Team of AMSS & Co., Delhi.

#### Limitation:

The course being highly technical, did not attract many students. However, after the completion of the course and the manner in which it was conducted, generated lot of interest among them.

#### Its main objectives:

- 1. To promote fairness and just reasoning among the students free from any prejudice and bias.
- 2. To give students a better understanding of the justice system at appellate levels.
- 3. To help students learn the way of consolidating an argument in a well-planned and systematic manner.
- 4. To help students learn the writing skills as well as drafting skills in a legal and judgment format.

#### The Context:

The role of an advocate is to help the judge reach to a conclusion. This has often been misconstrued by the students that the role of advocate is to argue and win the case. So to remove the misconception as to their role this competition was started because the best way to help a judge is to know what the judge thinks and wants which in turn can be known by sitting on his chair for a moment and to think the way a judge would think on a particular case. To help students provide reasoning to their contention and help them make good arguments with reason by letting them figure out the reason behind the judgment themselves, this competition was organised. Also, observing recent trend of inclination of students to the corporate world, this competition was started to attract the interest of more students towards the judiciary.

## The practice:

The competition has a novel concept of putting the students into the shoes of a judge and write a judgment that is fair and just without any bias and prejudice carrying with it all the analytical, legal and logical reasoning. The competition being a inter college competition in which various entries all across the country was invited received a lot of appreciation for such an effort by the college. This competition involves preparation of an alternative draft of a judgment by the participant on a case which has already been decided by the Supreme Court or a High Court. Participant must be able to problematize an original existing judgment and should prepare an alternative judgment which should be considered as a substitute to the existing one by the Examiners of the competition. Participants need not restrict to the order or findings expressed in the original judgment; they may arrive at their own conclusion and order. Arguments and reasoning need not be restricted to that expressed in the original judgment, a judgment or an order of the Supreme Court or a High Court. Prizes and Awards for the top three entries are awarded with Consolation prizes for the entries at fourth and fifth position.

#### **Brief Overview of the Competition:**

The competition has two rounds:

<u>First Round</u> – All alternate judgments received is assessed, and top 10 or 5 is selected for the second round.

<u>Second Round</u> - Student authors of these 10/5 judgments shall make oral presentations of their drafts in the ILS Law College. Oral presentations of 10 selected judgments shall be held. The exact dates for this round is communicated to the participants before the first round.

Prizes are sponsored by the Nani Palkhivala Foundation with First prize receiving Rs.5000/-followed by the Second prize of Rs.3000/- and Third prize of Rs.2000/-. Also, 2 Consolation prizes of Rs.1000/- each is awarded to the entries at fourth and fifth position.

In the year 2014-15, the judgment in the case Vishwa Lochan Madan v. Union of India (AIR 2014 SC 2957) was given for the competition. The total number of entries received was 15 from colleges across the country. The first prize was won by a team from GNLU while the second prize was bagged by a team from ICFAI Law School Hyderabad.

#### Limitation:

The competition is highly time consuming for students which leads to fewer entries for the competition. We are yet to work on encouraging and providing more awards and prizes to motivate students to participate in this competition.

## **Analysis of Feedback Year 2014-15**

The feedback was taken from 52 students from  $5^{th}$  year about curriculum reform.

Following questions were asked

1	Whether there should be more flexibility/ variety in choice of subject available? 53.8% of students answered this question in negative. 46.2 % of students felt that there is a need for providing more choice and flexibility.
1	Whether there is lack of legal subject in pre law years? 40.4% of students felt that the present curriculum is well designed and does not lack in any respect. However, 59.6% of the students felt that there is lack of legal subject in pre law years.
1	Whether there is lack of specialization in the current curriculum? 44.2% of the students felt that there is no lack specialization in the current curriculum. 55.8% of the students felt that there is lack of specialization in the current curriculum.
1	Whether there should be reduction in content? 92.3% of the students stated that no reduction in content is needed. This shows satisfaction on the part of the majority of the students in respect of the present syllabus. Very less number of students i.e. 7.7 % indicated reduction in content.
2	Do think there are enough supplementary and inter disciplinary courses available in the college?  36.5% of the students think that there are enough supplementary and inter disciplinary courses available in the college. 40.4% of the students have answered the questions in negative. Out of 23.1% of the students 9.6% of the students did not give any reply and 13.5% of the Students opted for 'Can't say' Option.
