#### Admissions Procedure

The college proceeds to admit students to the 1<sup>st</sup> year of LL M. (1<sup>st</sup> year of two year post graduate course). The procedure is mentioned below.

- 1. The lists given below are arranged as follows:
  - a. By categories : Open: Outside Maharashtra, Open: Within Maharashtra, and Reservations: SC, ST, OBC, NT / VJNT, Physically Handicapped, Servicemen/Ex-Servicemen. (See para 8. below for rules for Outside Maharashtra and Within Maharashtra categories)
  - b. In each category, applicants are arranged in the order of merit. Merit is calculated as a percentage on the basis of <u>all marks</u> in <u>all subjects</u> of the qualifying exam. It is not calculated on the basis of 'best four' or 'best five' or the like.

Where the percentage at the qualifying exam is equal, applicants will be arranged in order of percentage marks of the total of all subjects at Graduation examination.

**Note**: Where the result of the qualifying examination indicates only grades, the application is not considered unless conversion to marks is also stated.

2. These lists are provisional, and based on the faith and assumption that the information and documents submitted are true and correct. The decision of admission is subject to scrutiny of original mark sheets and documents at the time of interviews.

#### <u>General</u>

1. Admissions are at the sole discretion of the Principal. The decision of the Principal is final.

No other person is authorized to grant or to promise or to make any representation regarding admissions.

- 2. All admissions are provisional, to be confirmed by the Principal and Admissions Committee; and subject to further approval by the Savitribai Phule Pune University.
- 3. Admission is not confirmed merely because the name of the candidate appears in the merit list. The admissions will be confirmed on the basis of further scrutiny of forms and original certificates.
- 4. If the candidate (or anyone on behalf of the candidate) attempts to influence the admission process directly or indirectly, the candidate will be disqualified.

#### **Basis of admission**

- 1. Admissions to 1st year of LL M are based on merit.
- 2. Admissions will be confirmed in the order in which the names appear in the merit lists. The first merit lists of different categories are given below.
- 3. If the candidate is a Non Resident Indian (NRI), Foreign National, Person of Indian Origin (PIO), or a Child of Indian Workers in Gulf & South East Asia, please see below for more information.

#### <u>Merit lists</u>

- 1. Merit Lists are given below according to categories.
- 2. <u>Remaining vacant seats will be filled up on 'First Come First Serve'</u> <u>from 11<sup>th</sup> July 2017.</u>

#### <u>Interviews</u>

The candidate whose name appears in the merit lists given below, must <u>personally</u> attend the interview on either 8<sup>th</sup> July 2017, Saturday, or 10<sup>th</sup>, July 2017, Monday. Time-table and venue is given below.

If the candidate cannot personally attend the interview at the given time, the college will not consider the admission of such candidate later. Admissions will proceed further to candidates next in line. The college will not entertain any requests for postponement, whatever the reason.

- 2. The candidate must attend interview at the time given below, and at his/her own expenses.
- 3. The candidate must produce <u>all original</u> documents and a set of photocopies of the same for scrutiny at the time of interview. The candidate will not be admitted in case all the original documents are not submitted at the time of interview. The college will postpone the interview or admission for presenting documents.
- 4. The college will not admit the candidate if,
  - a. The candidate does not personally attend the interview, or
  - b. The candidate remain absent when called for the interview, or
  - c. The candidate does not produce original documents for scrutiny at the interview, or
  - d. the documents are incomplete, or
  - e. the application is not complete, or if the candidate has not filled in Application form online, or
  - f. the candidate does not pay fees (online) immediately after the interview, or
  - g. the candidate does not complete other formalities after the interview, or
  - h. the candidate is not eligible under the rules and provisions applicable to admissions
- 5. The candidate must complete the admission procedure according to the interview schedule.

## <u>Documents</u>

The candidate must submit at the time of interview the ORIGINAL and one selfattested copy of the following documents. To self-attest a copy, write 'TRUE COPY' on a visible part of the document, and sign.

- 1. Two copies of passport size, recent photograph
- 2. Statement of marks of the qualifying exam (LL.B/ BA LL B).
- 3. SSC or Xth or equivalent certificate.
- 4. HSC or XII th or equivalent certificate
- 5. Graduation marksheet, if any.
- 6. B A LL B or LL B marksheet (conversion pattern for graded marksheet)
- 7. Passing Certificate of BA LL B or LL B examination
- 8. Transfer Certificate of the College you attended.
- 9. Migration Certificate of the University or College or Board or School you attended, if it is affiliated to any university other that Savitribai Phule Pune University (If you do not have it at the time of interview, you must undertake to submit it within fifteen days from the date of admission.)
- 10. If the candidate seeks a seat in the reserved categories,
  - a. Valid and subsisting caste certificate issued by appropriate authority
  - b. A valid and subsisting certificate from the appropriate authority that you do not belong to the Creamy Layer, if you seek admission in such sub-categories among NT, VJNT, OBC, SBC to which the creamy-layer criteria is applicable.
  - c. A valid and subsisting certificate issued by the Civil Surgeon or Competent Authority under the Persons with Disability Act, 1995, if you seek admission and benefits in physically handicapped category.
  - d. A certificate issued by the Zilla Sainik Board if you are a child of an exserviceman, and issued by the appropriate authority if you are a child of an active serviceman of defence forces.
- 11. Domicile certificate (if applicable)
- **12.** Online Application form copy (with Application ID)- printed only on Ledger Paper.
- 13. Anti Ragging Undertakings : You are requested to fill up online Anti-Ragging undertakings on : www.amanmovement.org OR www.antiragging.in

### <u>Fees</u>

1. After the interview procedure, the candidate must pay fees within two days from the admission process. The candidate must pay the fees online via the payment gateway ( on website of the College) A Receipt will be generated which should be produced at the college office (2 copies) to collect Roll number and the procedure is complete.

2. The amount of fees the candidate pays is as follows:

- 3. If the candidate does not pay the fees within two days of the admission process, he/she will be deemed to have given up his/her claim for admission, and the college will admit the candidate next in order of merit.
- 4. The candidate may refer to the Prospectus for more details about fees, payment, concessions etc.
- 5. The candidate shall pay any increase in fees, if increased during the academic year under any rules, orders or directions given by the State Government, Savitribai Phule Pune University, the EIRA or other authorities.
- 6. If the candidate cancels his/her admission the fees will be refunded according to the rules of the Savitribai Phule Pune University. In any case, there is no refund of the fees if the candidate cancels admission after thirty days from the date of admission.

### <u>Lectures</u>

Lectures of 1<sup>st</sup> LL M will commence from 15<sup>th</sup> July 2017.

### <u>Hostel</u>

Hostel facility is available on the campus. For admission to the hostel the candidate may apply as soon as the admission to the college is complete and confirmed.

### Foreign Nationals, PIOs, NRIs

- 1. If the candidate is a (i) Foreign National, (ii) Person of Indian Origin, or (iii) Child of Indian Workers in Gulf and South East Asia, the admission will be processed by the Pune University.
