1. **Justice Prabha Sridevan (Retd.)**

"Challenges in Intellectual Property Law: a Judge's Perspective."



She was the Chairman of the Intellectual Property Appellate Board from 2011-2013. The Yahoo patent, the Nexavar compulsory licence, the Thalappakatti Biryani trademark are among the cases decided by her during this period. She has recently been asked to head the 'Think Tank' to frame India's National IPR policy.

2. **Honourable Justice Gautam S. Patel, Bombay High Court**

"Trademark Laws and its Changing Dimensions in India"



He started practice in 1987 in Mumbai, working on commercial, corporate and civil litigations, He has penned down various landmark judgments in the field of Intellectual property rights such as the recent 'Café Madras'.

3. Mr. Praveen Anand Managing Partner, Anand and Anand

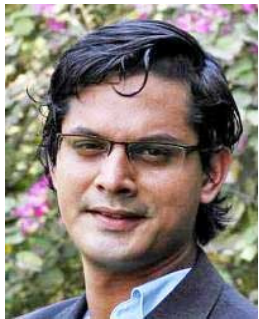
“Changing Dimensions of Patent Law in India”



He has been a counsel in several landmark IP cases involving the first Anton Piller Order (HMV cases); the first Mareva Injunction Order (Philips case); the first Norwich Pharmacal Order (Hollywood Cigarettes case); Moral rights of Artists (Jatin Das case); India's first framing case (TATA diamonds case); First order under the Hague Convention (Astra Zeneca case) and the most recent big ticket Patent litigation cases filed against Novartis, Pfizer and Roche.

4. Dr. Shammaad Basheer, Founder Spicy IP

“Access to Knowledge”



Prof. Shammaad is Founder and Managing Trustee, Increasing Diversity by Increasing Access, and Founder, SpicyIP, India. He joined the National University of Juridical Sciences (NUJS), Kolkata in November 2008 as the first Ministry of Human Resource Development Chair Professor in Intellectual Property law. Prior to this, he was the Frank H Marks Visiting Associate Professor of Intellectual Property Law at the George Washington University law school in Washington DC. Recently the Infosys Prize, 2014 in Humanities is awarded to Prof. Shammaad Basheer for his outstanding contributions to a broad range of legal issues and legal education.

5. Dr. Pradeep Apte

“Economic Analysis of Intellectual Property.”



He has worked extensively in the field of macroeconomics, public finance and agricultural economics. An expert in input-output analysis, he has played a key role in various programs targeting the development at grass root levels in Maharashtra. A consultant to the World Bank and the World Trade Centre, India, Prof. Apte also teaches Economics at Fergusson College, one of the premier educational institutes in the country.
