

# **Mediation Training Programme - FAQs**

## 1. When do applications open and what is the deadline for applying?

➤ The admissions for the training in December 2021 begin on 23<sup>rd</sup> November 2021. The last date for submitting applications is 30<sup>th</sup> November 2021. The maximum number of participants shall be 30.

## 2. From where can one download and submit the application for admission?

The application form for admission is available at <a href="http://ilslaw.edu">http://ilslaw.edu</a>. The Google form must be duly filled and submitted; based on the form, participants will be shortlisted; shortlisted participants will then be sent the link for payment of fees. Admission to the course will only be confirmed upon payment of the course fee.

## 3. Whether the Training Programme is online mode or classroom mode?

➤ The Training Programme for December 2021 shall be conducted online. Attendance for all 40 hours of the Programme is mandatory; videos of the participants must remain on at all times.

### 4. What is the duration of the Programme?

➤ The duration of the course is 40 hours divided over 9 days (3<sup>rd</sup> December 2021 to 12<sup>th</sup> December 2021).

#### 5. What is the Fees structure?

> The fees for the Programme is as under:

**Students:** 12,000+2160 (GST) = INR 14,160/-

**Professionals:** 15,000+2700 (GST) = INR 17,700/-

#### 6. How will the assessment be done?

The assessment for the Training Programme will be done on two criteria:

a. Assessment based on a simulation exercise on the last day of the training, which will be recorded and reviewed by a neutral panel of mediators.

b. Theory assessment (online) of 50 marks – consisting of MCQs as well as LAQs to be submitted within one week of the completion of the Training.

Attendance of all 40 hours of the training is mandatory for a student to be eligible to receive the certificate.

## 7. Who can apply to the course?

> Students, advocates, academicians, professionals, and any other person interested to be a mediator and/or pursue a career in mediation.

## 8. Why this course?

➤ ILSCA 40-hours Mediation Training Programme trains participants in honing their skills to be efficient mediators. Successfully completing this course will mean that participants are mediators, certified and accredited by the ILSCA. This will also open the gateway for successful participants to be empaneled with the ILSCA. It is to be noted here that the Training Programme is only a gateway and does not absolutely guarantee empanelment. In deciding upon the same, the candidate's experience, understanding and such other criteria as the ILSCA deems fit may be taken into consideration.

## 9. What is the cancellation policy?

➤ Candidate who intends to withdraw their admission must submit an application expressing his inability to continue with the course with valid reasons at least four (4) days prior to the commencement of the course to avail a refund. Fees once paid will not be adjusted to the subsequent course, under any circumstances, after the commencement of the course for which the fees are paid.
