

# Diploma in Housing Laws

## Frequently Asked Questions

### **1. Is Diploma in Housing Laws conducted by the Institute of Advanced Legal Studies (IALS) recognised by any University?**

- No. This course is an autonomous course conducted by the Indian Law Society, Pune.
- Indian Law Society is an independent body, is a public charitable trust, registered under the Society's registration Act and has no affiliation with the UGC nor with the University of Pune nor is a deemed University.
- Thus, Indian Law society is free to design its courses – as regards, the design, its curriculum and its duration and its methods of assessment.
- Various Diploma/certificate courses including Diploma in Housing Laws are run by the Indian Law Society with due approval of the Governing Council of the Indian Law Society.

### **1. When do applications open for the year 2022-2023 and what is the deadline for applying?**

- For the academic year 2022-23, admission notice will be released on **15<sup>th</sup> November 2022**.
- The last date for submitting applications is **9<sup>th</sup> December 2022**

### **2. From where can one register and make the payment for the course ?**

### **3. Whether course is online mode or classroom mode?**

This year the course shall be conducted online.  
However, please note that **the attendance is compulsory**.

### **4. What is the duration of the Course?**

- The duration of the course is approximately 32 units - 3 months - Two-hour lectures -for four days in a week,
- Classes are conducted in the evening-between 6.00 p.m. to 8.00 p.m.

**5. What is the Fees structure?**

- Fees for the course Rs. 25000 (**With GST**) for students and 35,000 for professionals (**With GST**) (Fee structure may be subject to change)

**6. Whether study material will be provided?**

A comprehensive reading material will be provided to all students. Additional material (will also be provided online from time to time.

**7. Where will the assessment pattern be?**

At the end of the course the final assessment of the student is done based on

- Lecture analysis (participants can choose any of the lectures delivered online and review and submit a written report) (10 Marks)
- Group discussion (will be organised at the end of the course) (20 Marks)
- Attendance for the lectures- 75 % of the total lectures (minimum attendance required for being eligible to get the certificate at the end of the Program) (10 Marks)
- Online examination (60 marks) shall be conducted at the end of the course

**8. Are fresh graduates eligible to apply for the course?**

Yes, fresh graduates are eligible to apply for the course.

**9. What documents are to be submitted at the time of Admission?**

Candidates selected for admission are required to produce the following documents (scanned copies to be submitted online):

1. Passing Certificate of the qualifying Examination
2. Or Statement of marks of the qualifying Examination
3. One passport size photograph

**10. What is the cancellation procedure of the course?**

Candidate who intends to withdraw their admission must submit an application expressing his inability to continue with the course with valid reasons. The chart for refunding of the fees on withdrawal of admission is as under:

<b>On Cancellation of Admission</b>	<b>Fees to be refunded</b>
1. Within 8 days of admission	80 % of total Fees
2. 9 to 15 days of admission	50 % of total Fees
3. After 15 days of admission	No refund

**P.S.** - Fees once paid for the current DHL course will not be adjusted to the subsequent course, under any circumstances.
