The course is designed by Mr. Naval Satarawala Chopra, Partner, Amarchand & Mangaldas & Suresh A. Shroff & Co, in association with leading global practitioners and academics in this field.

Lectures will be held every Friday and Saturday over a period of 6 weeks, helping you avoiding crucial time spent away from your office or academics. The Diploma contact lectures will commence in November 2015 and endwith an examination in January 2016. The reading material for each lecture will be available at the library and students are required to obtain photocopies of this material for each lecture. It is vital that students pre-read this material in-depth prior to the lecture. Certain course work would be allotted to the students as a part of assessment.

#### Aims and Objectives of the course

- ◆ The aim of the course is to teach the basic provisions of the Indian Competition Act, 2002,:
- to study the law in its economic and market context,
- to consider particular business phenomena distribution agreements, licenses of intellectual property rights, cartels, exclusionary and exploitative behavior of dominant enterprises, joint ventures, merger control, etc. against the backdrop of the Treaty on the Functioning of the European Union (TFEU) generally and Articles 101 and 102 TFEU, and the EU Merger Regulation in particular.

#### **Teaching Method**

The course will be taught over a 90 minute lecture, to be held twice on Friday and once or twice every Saturday. The lectures will be held from 16:30 to 18:00 and 18:30 to 20:00 on Fridays and 14:00 to 15:30, and 16:00 to 17:30 on Saturdays, as the case may be.

#### Policy on participation and written work

The teachers of this subject expect a high degree of participation by the students and will follow the Socratic method of teaching. We will be assigning a student seating chart at the beginning of the lecture to ensure that students are in a

comfortable environment and are encouraged to participate. Students are required to have prepared answers to the questions asked under each lecture topic below.

Cases have been referred under each topic, along with references to the relevant paragraphs. These cases are available online. It is vital that students read in depth and understand the cases set as part of the lecture reading. During the course of the lectures, individual students can and will be called upon to respond to queries and discuss cases assigned.

#### **Guest Lectures**

There may be occasional guest lectures given by other academics, both Indian and international private practitioners, and officials from competition authorities. These guest lecturers are subject experts, having worked on Indian and international competition law and will conduct a few lectures and assist in teaching. This will be a rare opportunity for students to interact directly with these world renowned personalities in the field of competition law. **Preparation and reading for these lectures is essential**.

#### The examination method and format

A 3-hour examination will be set, requiring the student to answer 3 questions, of which at least one will be a problem question. Fifteen minutes are allowed for reading. The examination will be open-book.

#### **Textbook**

The textbook for the course is the sixth edition of Competition Law by Professor Richard Whish, published by Oxford University Press in 2008. It is compulsory for all students to purchase a copy of the book.

The course will be conducted by Ms. Rimali Batra.

Rimali is presently a Senior Associate with DSK Legal working in the Litigation and Regulatory team of DSK Legal, New Delhi. She graduated from ILS Law College, Pune in 2010 and thereafter completed her masters in law from University of Oxford, UK, where she studied "Regulations and Policy" as one of her subjects. She has earlier worked with J. Sagar Associates, Trilegal, ICICI Bank and taught at Jindal Law School.

Rimali has been practicing Energy Laws for over three years. She is a visiting faculty with Symbiosis Law School and also a faculty with IALM Online School where she takes various short courses on Regulations, including Energy Laws. #### **Course Objective:**

The course in Energy Law would help the students understand the laws and regulations concerning the electricity or the power sector in India and the course is aimed at developing a functional understanding of theories relating to the legality and economics of Energy / Electricity.

The course would focus on legislation that govern generation, transmission, distribution, sale and purchase of electricity in India.

An area of law that monitors, regulates, defines and postulates the governance of renewable and non-renewable resources such as natural gas, oil, petroleum, electricity which resources are mandatory for generation of electricity, including thermal, solar, hydel, wind etc.

The study of Energy Laws introduces a student to processes; statutory, administrative and judicial in the interpretation of the laws and regulations governing the sector. This course is a crosscutting one, relevant to the understanding of laws that govern an essential commodity such as electricity.

The students will also be given an exposure in terms of latest regulations, judgements and policies pertinent to the Energy Sector, which gives them a deeper insight into the functioning of the energy sector in India.

The course also holds relevance for legal practice by students in future as it aims to prepare a student to take on a niche area of practice in big ticket law firms, companies and PSU's engaged in the sector.
