15. Multidisciplinary / interdisciplinary

ILS Law College is affiliated to Savitribai Phule Pune University (SPPU) and it offers the programs as directed by SPPU. The courses are designed to cover various facets of law which would intersect various disciplines that give multi-disciplinary as well as interdisciplinary approach towards study of law. In the entire teaching learning process of various laws, the teacher at ILS makes a deliberate attempt to give 360-degree bird's eye view to understand the subject thoroughly. In addition to the syllabus prescribed by SPPU, to give intricate multi-disciplinary approach, we also offer various courses like Gender and Law, Consumer Protection Law, Housing Law, Mediation as an alternative dispute resolution technique, Mental Health Law and Policy, to name the few.

16.Academic bank of credits (ABC):

Credit system gives a student an opportunity to fetch more skill sets during the curriculum itself. Since the approach is multidisciplinary and interdisciplinary, the student gets exposure to variety of issues and challenges if the credit system is available to him. However, ILS Law College is affiliated to SPPU wherein the system of Academic Bank of Credits (ABC) is envisaged to be implemented for law program from academic year 2023-24. At present, though there is no ABC system, various courses and activities which are taken by the students, do play an important role while getting admissions for further studies in universities abroad.

17.Skill development:

ILS Law College is a premier institute imparting legal education for more than 99 years, during which it has imparted socially relevant and professionally desired legal education. In the process, it has evolved its pedagogy in such a fashion that all the necessary skills to adapt to the existing socio-economic-cultural are honed in the students. Since the legal education

requires various comprehensive, analytical and application oriented skills, the necessary changes are brought in the teaching learning process. Understanding the importance of communication skills, ILS Law College also offers soft skills program. The teaching learning process incorporates participatory as well as experiential learning which in turn inculcate necessary skills of lawyers in our students. Considering the language barriers faced by the students having vernacular background, remedial courses in English and History are offered.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Law is encompassing all facets of human life right from the age of evolution of human race. As the human race evolved, the concept of society evolved; law also evolved. Our Shruti Smritis are the sources of law that provide base for Indian knowledge system. Yadnyavalkya smriti written by Vijdnyneshwar becomes the source of law that emphasizes Dharma as the origin of law. The entire process of evolution of law which comes from mitakshara and dayabhaga school of law becomes the part of our legal history. It is taught in the curriculum of law. The entire personal law especially Hindu Law is based on Indian knowledge system which subsequently got codified and incorporated in the curriculum by Bar Council of India. Till today, the coparcenary system which is a part of Indian knowledge system is not yet codified, and we apply it even today to determine the share in the coparcenary property. The Indian Evidence Act, the Indian Penal Code also is a result of the evolution of jurisprudence over the period.

The Indian knowledge system which is originally in Sanskrit is subsequently translated in other languages. However, the law curriculum being taught in English, teachers try to use Sanskrit verses and commentaries on Shruti Smriti and Vedas to explain the link between Indian knowledge system and the existing law.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

We ensure that our teaching-learning process is focused and centered around the goals that we have envisaged in our vision and mission statement while imparting legal education to the students. We offer the courses that are prescribed by Savitribai Phule Pune University. The Course outcome and Program Outcomes are already enlisted in the syllabi of the University. We plan the student-centric teaching-learning methodology in

which the course delivery and assessment are aimed to achieve the stated objectives and outcomes. While offering the course Role Play, Demonstrations, Case studies, and problem-solving sessions are conducted to hone advocacy skills while understanding the legal principles. In each part of our outcomes-based education, practical applications of principles and theories are means of verifying and measuring the extent of attainment of the desired student learning outcomes. Such a student-centric method brings clarity to the student as well as the teacher, offers flexibility and freedom of learning, and avoids unnecessary comparison.

20.Distance education/online education:

The Bar Council of India does not recognize and approve any Program which offers legal education through distance learning mode. However, in order to bridge the gap between the curricula prescribed by Savitribai Phule Pune University and emerging areas of new laws that are envisaged to meet the changing needs of complex society, we offer online certificate and diploma courses where national and international experts are The online lectures are conducted invited as resource persons. taking into consideration the convenience of resource persons and The evaluation process is also conducted online. the students. The online study material is made available to the students. These programs helps in bridging the gap between theory and practice. Apart from these autonomous programs, various online competitions like quiz competitions and Advocacy Skills Competitions also give students opportunities to learn.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

Integration of crosscutting issues into curriculum ensures holistic and interdisciplinary approach to study of law.

Importance of adherence to and need of ethical practice, duties and conduct of lawyer is imbibed through courses governing different aspects of legal profession including ADRM system. Public Policy and Public Administration course seeks to imbibe

ethical and moral values in Judicial Administration. Interactive sessions organised with practitioners and court visits provide an opportunity to students to observe court mannerism, etiquettes etc.

Integrating gender values and gender perspective through curriculum leads to acceptance of gender equality as a fundamental social value. The curriculum introduces the concept of gender and its intersectionality with other crosscutting factors. 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organizes special Programmes for advanced learners and slow learners

The admissions are governed by CET Cell and are merit based. Therefore, initial identification of learning levels is students' CET score and marks obtained in qualifying examinations. Continuous student-teacher interaction, peer support and Mentor Mentee system help identify the issues faced by students in the teaching learning process and to assess their learning levels. Knowledge gaps are identified by teachers through classroom interactions and internal evaluation.

Orientation Sessions are conducted for elective courses giving brief background, scope, and content of the subjects which helps students make an informed choice. English being the language of instruction and evaluation, as well as the official language of High Courts and the Supreme Court, we ensure the language barrier is taken care of in case of students with low proficiency in English. Students' English proficiency is tested during viva-voce examinations and necessary remedial measures are taken by English teachers in their classroom teaching. Remedial lectures in legal history are also conducted for students with language barriers. The Students' Welfare Department provides financial support for running these courses.

Under our TCLE program, Webinars, Certificate Courses, Diploma Courses are offered to give additional inputs to slow learners as well as advanced learners. Various co-curricular activities like Vidhishilpkar, Moot- courts, Judgment Writing, Client Counselling, Debating etc. are conducted in online mode to help students for their overall development.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Due to the pandemic, the lectures were conducted in online mode. College has subscribed to the G-suite Education Enterprise platform for conducting the Teaching- Learning activities. Through MyLoft Platform HEI has provided remote access to online legal databases and ebooks subscribed by the library. PowerPoint presentations, videos, e-content etc., were used in classroom sessions.

Online sessions not only include lectures but students are also involved in group discussions, panel discussions, student-teacher seminars, quizzes, video screening etc. These methods made online learning interesting by making students proactively participate in the teaching - learning process.

In addition to learning theoretical principles, students are also given an opportunity to test the ground reality through various experiences and simulations. The skills of client counseling and interview technique are imparted through online Role-play which is followed by classroom discussion. Demo sessions were conducted on Civil and criminal trials. Guest lectures on pre-trial preparation in civil and criminal cases, professional ethics were conducted. Students of LL.M. program engaged in peer teaching to get the first hand experience of the teaching-learning process.

Activities conducted by the various Cells and Centers in the college such as Negotiation Challenge, Client Counseling Competition, Moot Court and Debates complemented classroom teaching.

Teaching-learning processes for the AY 2020-21 were conducted online due to COVID-19 restrictions. ICT enabled tools were the mainstay of the teaching-learning process during this time. For the effective use of ICT, individual laptops were procured for all teachers. Classes were conducted through google meet via G-suite Education Enterprise Platform. Various features of Google meet like break out rooms, quiz, jam board, present screen were used by teachers to deliver lectures effectively and conduct various activities like group discussions and presentations. PowerPoint presentations, video screening, etc. were used extensively to supplement the classroom teaching.

Teachers were encouraged to participate in online FDPs on MOOCs and manage e-classrooms in order to well equip them for an effective teaching learning process. Training sessions were conducted for conducting online classes and effective use of google meet and classroom.

Prin. Gharpure Library has subscription of over 13 online databases like AIR Online, SSC Online, INFLIBNET/ NLIST, etc. which were used by all the teachers as primary source of reference. Library has subscribed to 'MYLOFT- a remote access platform which has integrated all subscribed legal databases. It is a mobile web-app platform which allows users to discoveraccess-organize-share, e-content of their personal and professional interest. This platform was used to access the said databases remotely during work from home by students as well as teachers.

The Internal Evaluation of the students is conducted as per the guidelines prescribed by SPPU which are scheduled by the examination department of the college.

Continuous Internal Evaluation- written assignment and vivavoce- was conducted online due to Covid restrictions. Notices, the syllabi and schedule of evaluation was displayed on the college website and in the google classrooms. The questions were uploaded to the classroom. Students submitted scanned copies of hand-written assignments in pdf/JPEG format within prescribed time-limit. Viva-voce was conducted on Google Meet. Reexamination, in the same format, was conducted for failed and absent students.

Evaluation of practical training papers is done internally. The schedule for moot presentations was displayed on the google classroom. Since the courts were closed, alumni presented simulation of Civil and Criminal cases.

All the practical tanning papers require submission of a journal on the basis of which Viva voce examination is conducted at the end of the year.

The students of LL.M. program were assessed continuously through online weekly assessment, tutorials, long term papers, dissertation and students were required to submit the same on google classroom.

The marks of the Internal Evaluation in all courses were communicated to the students on their individual online profiles.

The students can make an application to CEO regarding the grievance about internal evaluation. An aggrieved student can escalate his grievance to the Principal. At all the levels due hearing is given to the aggrieved student. Being a premier law college, ILS Law College has a dedicated Legal Aid Centre dedicated to the upliftment of the community through the efforts taken by our students and faculty members. Majority of the Legal Aid Centre's work involves on-site visits for the conduct of legal literacy camps and legal counselling at our partner organizations. INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning. viz., classrooms, laboratories, computing equipment etc.

HEI provides adequate facilities for the process of teachinglearning, by raising the requisite physical infrastructure; keeping a scope for its augmentation from time to time; and maintaining it regularly. It is spread over 154 acres of lush green campus in the lap of a hillock.

The physical infrastructure include Separate Administrative and Academic Buildings with ICT enabled classrooms, WiFi enabled with dedicated 100 MBPS leased line and various equipment to make the infrastructure and learning resources accessible to all including differently- abled. Infrastructure is provided for various co-curricular and extracurricular activities such as Moot Court Hall, State of Art Auditorium, Legal Aid Centre, Conference Hall etc. Residential Complexes for students and staff are provided on campus.

The Learning Resources include a Library with a rich collection of 54859 which includes text books, reference books and general books as well as digital databases, managed through updated Library Management Softwares. Subscription to Myloft for facilitating remote access to library resources by teachers and students.

Computer Lab and browsing centres with 55computers are provided for exclusive use by students. Researcher's cabin is provided for researchers. Individual laptops are provided to teachers to facilitate online teaching-learning during pandemic.

College also receives Endowments Funds, UGC grants, financial assistance from Savitribai Phule Pune University, Sponsorship for various activities from individuals as well as organisations and donations from Alumni. College also receives donations from thealumni/individuals in the form of kind for e.g. many books are donated for library use. Deficit of funds are managed by funding received from Indian Law Society. College Development Committee recommends Revenue and capital expenditure annually to Governing Council. Every department budget its activities in advance in consultation with Principal and accordingly, budget of the college is prepared. Major purchases are made with approval and sanction of the management. Tender/quotation system is followed for the major purchase of items. All formalities are duly complied with, and proper records are maintained for every purchase. All transactions are supported by vouchers. All funds are utilised for the purpose for which they are allocated. Secretary of the Society is responsible for monitoring and controlling the financial procedure. Attendance Policy

HEI strictly adheres to minimum attendance rules prescribed by the Savitribai Phule Pune University. Term of the students is withdrawn if they fail to fulfillminimum attendance requirement. During pandemic, the college teaching went online, and thus the issue of recording students' attendance during the classes became challenging. To overcome this difficulty, on the recommendation of IQAC, attendance for each lecture was recorded in online mannerand final attendance was displayed by HEIat the end of every month on website. These efforts of attendance committee and college office to record and display attendance consistently helped to institutionalize the practice of recording online lectures and not to divert with the rule of minimum attendance for grant of term.

Increment Policy for Contractual Staff of the College

Due to non recruitment policy of the State, many teaching and non-teaching grant-in-aid posts in the college are vacant. To maintain the quality of the teaching - learning process anditssmooth functioning the HEIhas recruited additional staff from its own funds on contractual basis. Many such staff members are working with the college since last many years. It was decided that if services of a contractual staff are continued in next year, increment in salary be given to him. A comprehensive increment policy was framed for this purpose. A total 28 teaching and non-teaching staffwere benefitted bythis.

Procurement of Laptop / Computers for All Staff:

Due to Covid 19 lockdown in March 2020, teachers and administrative staff were compelled to work from home. Teachers conducted online lecture from residence. College examination was conducted in online manner. Meetings (teaching and non-teaching) were conducted in online manner. Few teaching/non-teaching members didn't had laptop, few had a old Personal Computer at home. It was difficult for many to work with smart phone. Considering the requirement of all teaching and non-teaching members, IQAC recommended to procure laptops for all teaching and non-teaching members. College had purchased 39 laptops for staff in March 2021. Additionally, 16 new computers were purchased to meet the requirements.

Remote Access to online databases:

College subscribes to 13 online legal databases. They could be accessed from campus using IP based Access. During Covid 19 lockdown teachers and students faced difficulty to access online databases from home as the service providers didn't allow off-campus access. IQAC recommended the college library to make online databases available to all teachers and students off campus. Accordingly, MyLOFT facility was subscribed to make all online databases available remotely to all the teachers, students and staff with personal email address.

For smooth functioning of the teaching learning process, research amongst the teachers and students, we implemented MyLOFT consisting of significant databases and online research journals and books. The college also shifted the entire classroom teaching to G-Suite by purchasing a licensed version of G-Suite followed by training to all teachers and students on the functioning of G-Meet and the procedure of use of Google Classroom. Transformative pedagogy is adopted to effectively deliver curriculum. Preparation of academic calendar ensured adherence to teaching-learning schedule. HEI continued to deliver curriculum effectively in online mode. Virtual mode of teaching was supported by subscribing to G-Suite for Education Enterprise and training was given to teachers. MyLoft platform assured remote access to library. Teachers developed and shared e-content, reading material to assist e-learning. Guidance sessions were conducted for students. Curricular, extra-curricular activities are conducted to support curriculum delivery for experiential learning. Online facility of recommending books is provided.

Procedural laws and practical training courses are taught by practitioners. Courses, course outcomes and contents are informed to students in introductory sessions. Higher passing percentage and number of students placed in University merit list are reflectors of effective curriculum delivery. Feedback is obtained from students and teachers about curriculum delivery. Report of academic activities is submitted to the General Body.

Public Policy and Public Administration course seeks to imbibe ethical and moral values in Judicial Administration. Interactive sessions organised with practitioners and court visits provide an opportunity to students to observe court mannerism, etiquettes etc.

Integrating gender values and gender perspective through curriculum leads to acceptance of gender equality as a fundamental social value. The curriculum introduces the concept of gender and its intersectionality with other crosscutting factors. Concept of gender is to be studied in the context of pluralistic society, constitution, vulnerability and disadvantaged group, equality, right to work and associated economic rights, family relations, property rights etc.

Human values like equality, mutual respect, dignified treatment, empathy, inclusion, peace etc. are introduced and inculcated through courses touching upon different areas of human life.

Compulsory course on environmental Law equips students with basic knowledge and skills to understand environment and sustainability issues.

2.2.1 - The institution assesses the learning levels of the students and organizes special Programmes for advanced learners and slow learners

The admissions are governed by CET Cell and are merit based. Therefore, initial identification of learning levels is students' CET score and marks obtained in qualifying examinations. Continuous student-teacher interaction, peer support and Mentor Mentee system help identify the issues faced by students in the teaching learning process and to assess their learning levels. Knowledge gaps are identified by teachers through classroom interactions and internal evaluation.

Orientation Sessions are conducted for elective courses giving brief background, scope, and content of the subjects which helps students make an informed choice. English being the language of instruction and evaluation, as well as the official language of High Courts and the Supreme Court, we ensure the language barrier is taken care of in case of students with low proficiency in English. Students' English proficiency is tested during viva-voce examinations and necessary remedial measures are taken by English teachers in their classroom teaching. Remedial lectures in legal history are also conducted for students with language barriers. The Students' Welfare Department provides financial support for running these courses.

Under our TCLE program, Webinars, Certificate Courses, Diploma Courses are offered to give additional inputs to slow learners as well as advanced learners. Various co-curricular activities like Vidhishilpkar, Moot- courts, Judgment Writing, Client Counselling, Debating etc. are conducted in online mode to help students for their overall development.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Due to the pandemic, the lectures were conducted in online mode. College has subscribed to the G-suite Education Enterprise platform for conducting the Teaching- Learning activities. Through MyLoft Platform HEI has provided remote access to on-line legal databases and ebooks subscribed by the library. PowerPoint presentations, videos, e-content etc., were used in classroom sessions.

Online sessions not only include lectures but students are also involved in group discussions, panel discussions, student- teacher seminars, quizzes, video screening etc. These methods made online learning interesting by making students proactively participate in the teaching - learning process.

In addition to learning theoretical principles, students are also given an opportunity to test the ground reality through various experiences and simulations. The skills of client counseling and interview technique are imparted through online Role-play which is followed by classroom discussion. Demo sessions were conducted on Civil and criminal trials. Guest lectures on pre-trial preparation in civil and criminal cases, professional ethics were conducted. Students of LL.M. program engaged in peer teaching to get the first hand experience of the teaching-learning process.

Activities conducted by the various Cells and Centers in the college such as Negotiation Challenge, Client Counseling Competition, Moot Court and Debates complemented classroom teaching.

2.3.2 - Teachers use ICT enabled tools for effective teaching-learning process. Write description in maximum of 200 words

Teaching-learning processes for the AY 2020-21 were conducted online due to COVID-19 restrictions. ICT enabled tools were the mainstay of the teaching-learning process during this time. For the effective use of ICT, individual laptops were procured for all teachers. Classes were conducted through google meet via G-suite Education Enterprise Platform. Various features of Google meet like break out rooms, quiz, jam board, present screen were used by teachers to deliver lectures effectively and conduct various activities like group discussions and presentations. PowerPoint presentations, video screening, etc. were used extensively to supplement the classroom teaching.

Teachers were encouraged to participate in online FDPs on MOOCs and manage e-classrooms in order to well equip them for an effective teaching learning process. Training sessions were conducted for conducting online classes and effective use of google meet and classroom.

Prin. Gharpure Library has subscription of over 13 online databases like AIR Online, SSC Online, INFLIBNET/ NLIST, etc. which were used by all the teachers as primary source of reference. Library has subscribed to 'MYLOFT- a remote access platform which has integrated all subscribed legal databases. It is a mobile web-app platform which allows users to discover-access-organize-share, e-content of their personal and professional interest. This platform was used to access the said databases remotely during work from home by students as well as teachers.

2.5 - Evaluation Process and Reforms

2.5.1 - Mechanism of internal assessment is transparent and robust in terms of frequency and mode. Write description within 200 words.

The Internal Evaluation of the students is conducted as per the guidelines prescribed by SPPU which are scheduled by the examination department of the college.

Continuous Internal Evaluation- written assignment and vivavoce- was conducted online due to Covid restrictions.

Notices, the syllabi and schedule of evaluation was displayed on the college website and in the google classrooms. The questions were uploaded to the classroom. Students submitted scanned copies of hand-written assignments in pdf/JPEG format within prescribed time-limit. Viva-voce was conducted on Google Meet. Re-examination, in the same format, was conducted for failed and absent students.

Evaluation of practical training papers is done internally. The schedule for moot presentations was displayed on the google classroom. Since the courts were closed, alumni presented simulation of Civil and Criminal cases.

All the practical tanning papers require submission of a journal on the basis of which Viva voce examination is conducted at the end of the year.

The students of LL.M. program were assessed continuously through online weekly assessment, tutorials, long term papers, dissertation and students were required to submit the same on google classroom.

The marks of the Internal Evaluation in all courses were communicated to the students on their individual online profiles.

In case of any inability to appear for the internal examinations online due to various unavoidable circumstances like internet failure, network connectivity issue, power-cut, natural calamity, etc., examinations were conducted telephonically.

The students can make an application to CEO regarding the grievance about internal evaluation. An aggrieved student can escalate his grievance to the Principal. The students of post graduate programs can take up their grievances with their Head of the Department which may be, if required, escalated to CEO and Principal. At all the levels due hearing is given to the aggrieved student. Since all the internal evaluation is online, we have preserved the recordings of viva-voce in the central repository and have also saved the written assignments on the drive which may be referred for evidence in case of grievance.

Being a premier law college, ILS Law College has a dedicated Legal Aid Centre dedicated to the upliftment of the community through the efforts taken by our students and faculty members. Majority of the Legal Aid Centre's work involves onsite visits for the conduct of legal literacy camps and legal counselling at our partner organizations. INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

HEI provides adequate facilities for the process of teaching-learning, by raising the requisite physical infrastructure; keeping a scope for its augmentation from time to time; and maintaining it regularly. It is spread over 154 acres of lush green campus in the lap of a hillock.

The physical infrastructure include Separate Administrative and Academic Buildings with ICT enabled classrooms, WiFi

enabled with dedicated 100 MBPS leased line and various equipment to make the infrastructure and learning resources accessible to all including differently- abled.

Infrastructure is provided for various co-curricular and extracurricular activities such as Moot Court Hall, State of Art Auditorium, Legal Aid Centre, Conference Hall etc.

Residential Complexes for students and staff are provided on campus.

The Learning Resources include a Library with a rich collection of 54859 which includes text books, reference books and general books as well as digital databases, managed through updated Library Management Softwares. Subscription to Myloft for facilitating remote access to library resources by teachers and students.

Computer Lab and browsing centres with 55computers are provided for exclusive use by students. Researcher's cabin is provided for researchers. Individual laptops are provided to teachers to facilitate online teaching-learning during pandemic.

Covid pandemic created a very unprecedented situation. The future of the academic processes was in danger. The education system itself was undergoing a sea change. At such times, it was very difficult to come out with a new strategic plan. Also, the advent of the pandemic had made completion of few of the targets of the previous strategic plan difficult. Hence, it was decided to continue with the same plan for the academic year 2020-21 as well. Attendance Policy

HEI strictly adheres to minimum attendance rules prescribed by the Savitribai Phule Pune University. Term of the students is withdrawn if they fail to fulfillminimum attendance requirement. During pandemic, the college teaching went online, and thus the issue of recording students' attendance during the classes became challenging. To overcome this difficulty, on the recommendation of IQAC, attendance for each lecture was recorded in online mannerand final attendance was displayed by HEIat the end of every month on website. These efforts of attendance committee and college office to record and display attendance consistently helped to institutionalize the practice of recording online lectures and not to divert with the rule of minimum attendance for grant of term.

Increment Policy for Contractual Staff of the College

Due to non recruitment policy of the State, many teaching and non-teaching grant-in-aid posts in the college are vacant. To maintain the quality of the teaching - learning process anditssmooth functioning the HEIhas recruited additional staff from its own funds on contractual basis. Many such staff members are working with the college since last many years. It was decided that if services of a contractual staff are continued in next year, increment in salary be given to him. A comprehensive increment policy was framed for this purpose. A total 28 teaching and non-teaching staffwere benefitted bythis.

College examination was conducted in online manner. Meetings (teaching and non-teaching) were conducted in online manner. Few teaching/non-teaching members didn't had laptop, few had a old Personal Computer at home. It was difficult for many to work with smart phone. Considering the requirement of all teaching and non-teaching members, IQAC recommended to procure laptops for all teaching and non-teaching members. College had purchased 39 laptops for staff in March 2021. Additionally, 16 new computers were purchased to meet the requirements.

Remote Access to online databases:

College subscribes to 13 online legal databases. They could be accessed from campus using IP based Access. During Covid 19 lockdown teachers and students faced difficulty to access online databases from home as the service providers didn't allow off-campus access. IQAC recommended the college library to make online databases available to all teachers and students off campus. Accordingly, MyLOFT facility was subscribed to make all online databases available remotely to all the teachers, students and staff with personal email address.

The college is also home to Gender Studies Cell and Women Studies Centre which take up various sessions and certificate courses for creating awareness on gender related issues.

Solid waste management

• Organic Waste Composting Machine(OWC): The College uses OWC which uses bio sanitizer, fungus, bacteria scientifically to process the solid waste.

The Manure is used in the garden which enhances the fertility of the soil.

- Segregation of Dry and Wet Waste: segregation Dry and Wet waste generated at the Hostels, Mess, Canteen and residential quarters collected twice a week by the PMC waste collection vans.
- Natural composting College has adopted the traditional method of "Natural composting", where dry leaves undergo the process of composting generating compost used for soil conditioning and lawn dressing.

Liquid waste management

- Water Filtration Plant: installation of a Water Filtration Plant at swimming pool for filtering pool water and pumps back the clean water in the swimming pool.
- Breeding Guppy fish: The College has an innovative method of filtration of water as well as safeguarding against the spread of mosquito-borne illnessesby breeding "guppy fish" in the institution's water pond.

E-Waste management:

E-waste generated in the college is disposed-off

through proper agencies. The institution is now moving towards using "green toners" for its printers.

The college has installed an Automatic Sanitary Napkin Incinerator Machine in the ladies' washroom.

In the academic year, the College implemented Remote Access to Library for furtherance of academic interest during COVID19. For smooth functioning of the teaching learning process, research amongst the teachers and students, we implemented MyLOFT consisting of significant databases and online research journals and books. The college also shifted the

entire classroom teaching to G-Suite by purchasing a licensed version of G-Suite followed by training to all teachers and students on the functioning of G-Meet and the procedure of use of Google Classroom. Study material, PPTs and reading material was shared on the google classroom.
