

- 1. We already have subscribed to the Google Workspace for Education Fundamentals: free of cost since December 2019.
- 2. Few features in the Education Fundamentals were available free of cost during the pandemic. However, features such as a Maximum number of participants to 250 and breakout rooms, etc. was stopped in January 2021. Hence, we had taken an additional subscription of G-Suite for education enterprise (called Google workspace for education plus-legacy), on 24th February 2021, for 20 users, which will expire on 24th February 2022.
- 3. Also the Education fundamentals has stopped the Meet recording feature from 9th January 2022, which was available for all faculty members till then.
