The 10th ILS Intra-College Client Counseling Competition was conducted in 3 rounds from October 9-11, 2022. A total of 36 teams participated in the preliminary rounds. 6 teams participated in the semi-final rounds and 2 teams participated in the final rounds. The schedule was released on 17th September and the Rulebook was released on 21st September.

ORIENTATION AND DEMONSTRATION:

The orientation and demonstration for the competition was held on 19th September for counsels. A demo session was conducted by a team of Dristi Agrawal, Richi Jain as counsels, and Anoushka Singh who acted as the client. The rules of the competition were explained by the Organizing Committee, which was followed by a clarification session.

An orientation for the clients took place on September 20, 2022. A demonstration was conducted here too. The Organizing Committee explained the role and importance of the clients to those attending. This was followed by a Group Discussion on September 21, 2022 for the selection of clients.

The registration for the counsel teams took place on September 22, 2022 and the list of selected counsel teams was released on September 24, 2022.

Structure of the Competition: The 13th Judgment writing competition was organized on April 15, 2023, at the ILS Law College; in the memory of Judge Shri. P.N. Behere, a former District and Sessions Judge of Pune, and President of the Pune District Consumer Forum.

The Competition was open for the students from the last two years of BA LL. B and LL.B. programs and for LL.M. students. Teachers and other students witnessed the proceedings. Justice Mridula Bhatkar (Retired Judge Bombay High Court) has instituted a prize in memory of Judge Shri. P.N. Behere. She was present throughout the competition and shared her thoughts. Hon'ble Justice Nijamoodin Jahiroddin Jamadar, Judge, Bombay High Court was the Chief Guest. He inaugurated the Competition, presided over the proceedings as a judge and guided the students. Shri. Bhalchandra Patwardhan, Advocate presented arguments for the Complainant. Shri. Yuvraj Narvankar, Advocate presented an argument for the Respondent. The facts of the case were inspired by the real case and were modified considerably to suit the requirements of the Competition. Eligibility: The Annual Intra-College Novice Moot Court Competition 2023 was open for participation by students in First Year BA LLB & First Year LLB at ILS Law College, Pune. **Structure and Dates of the Competition:** The competition was conducted in three rounds viz. Preliminary Round (17th February 2023), Semi-Final Round (February 24, 2023) and the Final Round (February 25, 2022).

Cases for the Competition:

Participants were given the option to choose one among the following four moot propositions released on February 1, 2023 for the preliminary round based on different areas of law:

- Law of Crimes drafted by Sahas Arora (V BA LLB)
- Law of Contracts drafted by Anubhav Sinha and Meenal Bhagat (V BA LLB).
- Constitutional Law drafted by Sahas Arora (V BA LLB)

For the semi-final and final rounds of the Competition, a new case based on Law of Torts drafted by Mihir Govande and Kashish Singhal (V BA LLB) was released. Students were assigned their sides at random by the Organizing Committee.

Number of Participants and Judges:

I. Preliminary Round-

Report

After two years of conducting the Annual Raghavendra Phadnis Moot Court Competition in an online mode due to Covid-19, the highly celebrated competition resumed its true form in the physical mode over the course of an entire month.

The Preliminary round of the Competition was conducted on August 27, 2022. The Semi-Final and Final Rounds were conducted on September 11-12, 2022 respectively.

Preliminary Rounds

The preliminary round of the Competition saw overwhelming participation of around 460 students. The participants were divided into 34 Courtrooms which were divided into morning and afternoon sessions. The Courtrooms were overseen by Courtroom Facilitators who played a key role in the successful conclusion of the competition. The Competition was adjudicated by 48 ILS Alumni who were experts in their respective subject matter.

Report:

The "Remembering S.P. Sathe: The 17th International Moot Court Competition 2023" was conducted from March 24-26, 2023 at ILS Law College, Pune in a physical mode. Students enrolled in a full-time bachelor's law program in any Indian/Foreign University at the time of the Competition were eligible to compete in the moot. The moot was divided into two Preliminary Rounds, Quarter-Final Rounds, Semi-Final Rounds and Final Rounds.

The moot proposition for this edition was drafted by Mr. Ritvik Kulkarni, Senior Associate, Khaitan & Co. with contributions by Mr. Anand Mohan, Counsel, Bombay High Court, and research assistance by Tejas Bhonge and Mihir Govande (both V BA LLB). The proposition was based on International Investment Law and Investor-State Dispute Settlement in line with the theme for this year i.e. 'Law & Economics'.

This edition of the moot was conducted in collaboration with the Singapore International Arbitration Centre [SIAC], the Centre for Trade and Investment Law [CTIL], the Savitribai Phule Pune University [SPPU] and the ILS Centre for Arbitration and Mediation [ILSCA]. We were also joined by SCC Online and Eastern Book Company as our knowledge partners.

12TH ILS INTRA-COLLEGE TRIAL ADVOCACY COMPETITION, 2022-23

Report: After months of diligence, preparation, and determination, the 12th ILS Trial Advocacy Competition, 2022-23 was successfully organized on February 4, 11 and 12, 2023 being the Preliminary Round, Semi-final Round, and Final Round of the Competition, respectively. The problem was named State (NIA) v Varad Pawar and revolved around the assassination of the Chief Minister of Maharashtra, the defection of political leaders, and a criminal conspiracy. The acts involved were the Unlawful Activities (Prevention) Act, 1957; the Explosive Substances Act, 1908; National Investigation Agency Act, 2008.

The problem had been drafted by the Organising Committee members Aakanksha Ranjan, Gunjan Suyal, Harinoor Jham, Varad Partani, Olivia Mathew, Aayush Ramachandran, Anushka Tasgaonkar, and Siddhant Chhabra.

Total 64 teams were registered, comprising 256 participants. Also, 112 students of I BA LLB and I LLB participated as witnesses.

After receiving registrations for witnesses, the students were arranged in groups, and discussions were conducted. Based on their engagement in the discussion, they were assessed and allotted a role accordingly. The witnesses then had to go through various witness training sessions where they were trained for the roles allotted to them.

To guide the students and give them a better picture of how chief and cross-examinations are held in the court, a special session was organized by the TAC organizing committee in collaboration with the Criminal Law Cell of ILS Law College.

The preliminary round was conducted on February 4, 2023 with 16 courtrooms and 2 rounds. The preliminary round was judged by various practicing advocates. The exercise of mooting is one of the highlights of every law curriculum. It teaches students skills quintessential for solving legal problems. These skills encompass both soft skills as well as writing skills. It is one of the appurtenant collaterals of any law school's curriculum and one which is most relished by most students.

This competition is a highly awaited event of the year and witnesses massive participation from students across all batches. In addition, MCS organizes the Novice Moot Court Competition to assist students in their first year of law school to acquaint them with the exercise of mooting.
