SEMINARS

Student Seminar I

Title of Session: From Farm to Table: The IP Way

Date: September 8, 2022

Mode: Offline

Name of the Resource Person: Isham Deshpande (II LLB) and Bhumisha Lodaya (V BA LLB)

No. of Participants: 37

Report of the Session: The seminar commenced with the definition of Food Security and its relevance to the IPR. A detailed discussion about the commercial value of genetically modified seeds was carried out. Additionally, statistical information was employed to provide a reality check on the current state of affairs. By illuminating the situation in India and how it lacks the sort of security offered, the first half of the seminar came to an end.

The later part of the discussion focused on the intellectual property protection granted to recipes and other culinary items in the Indian setting. Following a brief introduction to the subject, a comprehensive discussion on the idea expression dichotomy was held. Furthermore, the patentability of food recipes and food manufacturing procedures was explained. The presenter briefly mentioned the importance and need for trade secrets concerning secret recipes. The link between food plating and intellectual property protection was underlined. A discussion was held to determine if food plating came under the jurisdiction of the Design Act 2000.

Student Seminar II

Title of Session: Global IP and Cultural Rights

Report of the Session: The seminar started on a general note of International Trade Law. Student presenters explained the culmination of the GATT and WTO and thereby set a background for the further discussion. Further, important principles of the world trade law affecting the global IP law were discussed; namely - a) principle of national treatment and b) principle of most-favoured nation. Then the evolution of global IP law was discussed by giving a brief introduction to the TRIPS Agreement.

The second part of the seminar concentrated on the cultural rights vis-à-vis International IP Law. The topic commenced with discussions on what exactly is 'culture' and 'cultural rights', how and

why are the latter to be understood differently from the generic idea of intellectual property rights

which are necessarily individual rights. This discussion then moved to the rights of indigenous

population over biodiversity and the specific international instruments to that effect. How global

IP law via TRIPS agreement fails to adequately recognize and protect the said cultural rights.

The discussion ended on a deliberative note as to how the global IP and trade law regime should

proceed with bettering the conditions for the cultural rights holders.

was explained using various Indian as well as international case laws. The doctrine of fair use was

explained with the help of various examples. Following this, the concept of transformative works

and adaptive works and their difference was discussed.

up which primarily talked about Disclosure, Due Diligence and Addendums, after this the due

diligence by the influencers and the addendums to the rules were discussed along with comments

by both the presenters about the guidelines and its criticisms with their solutions.

The seminar concluded by highlighting the international status on protection of traditional knowledge and the possible solutions for effective protection of traditional knowledge.

Title of Session: Protect Your Moves

Report of the Session: The seminar began with the introduction to the field of Dance. The presenters along with the participants put forth their perceptions of the art form and discussed its various elements. Pointers like dance being a language, skill, form of expression and technique were elaborated.

The seminar proceeded with the discussion of provisions under which dance is protected which is under 'choreographic work' under Section 2(h) of The Copyright Act, 1957. Case laws highlighting attempts at copyrighting choreography were discussed. Rights like reproduction of sound and visual recordings, issuance of copies and distribution which a performer has were explained with relevant case laws. Participants put forth their views about Indian and Western classical dance forms and an interesting topic about originality of these classical dance forms got everyone engaged. A short discussion on protection of dance under different types of IPs like design, patent and trademarks took place.

The Seminar saw robust student participation and discussion.

foreign jurisdictions such as Australia, United Kingdom, USA were compared with the Indian

scenario. Ultimately the impact of the guidelines was discussed. The seminar concluded with an

activity wherein the participants reviewed a dummy contract of a child artiste in reference to Indian

Laws.

The inherent nature of raag, taal, pakad, aaroh and avroh was explained to understand the rigid compositional scope of classical music was a contention in the case under discussion

Title of Session: Compulsory Licensing of Medical Technology

Report of the Session: The session was opened with a brief discussion regarding the role of IPR in medicine, and the importance of protecting inventions especially in the medical field, establishing a basis for the rest of the session. The high cost of development and long development cycle for pharmaceutical products was discussed. Next, the importance of access to medicines and healthcare was brought up-leading to a discussion on balancing the need for accessing medicine as a public good with the protection of inventions through IPR as an impetus for innovation.

The important provisions regarding compulsory licensing in the TRIPS agreement and the patents

act were covered, with a brief explanation of how these provisions could be implemented to ensure

adequate responses in cases of healthcare crises. The next part of the session covered a few case

studies of attempts to enforce compulsory licensing both internationally, and domestically, going

over a brazilian policy which compulsorily licenses hiv/aids medication, as well as two cases in

Indian Courts- Bayer v. NATCO and Lee Pharma v. Astrazeneca. The session closed with an

overview of the current position of law with regard to compulsory licensing in India in light of the

above-mentioned cases.
