

## Post Graduate Diploma in Alternative Dispute Resolution Methods (PG-ADRM) (Through Distance Learning)

## FREQUENTLY ASKED QUESTIONS

- 1. Is the Post Graduate Diploma in Alternative Dispute Resolution Methods conducted by the Indian Law Society for Arbitration and Mediation (ILSCA) recognized by any University?
  - No. This course is an autonomous course conducted by the Indian Law Society, Pune.
  - Indian Law Society is an independent body, is a public charitable trust, registered under the Society's Registration Act, and has no affiliation with the UGC nor with the University of Pune nor is a deemed University.
  - Thus, the Indian Law Society is free to design its courses as regards, the design, its curriculum, duration, and methods of assessment.
  - Various Diploma/certificate courses including the PG Diploma in ADR Methods are run by the Indian Law Society with due approval of the Governing Council of the Indian Law Society.
  - We call the course PG Diploma because we only admit students who are graduates in any faculty law science or arts.
- 2. Does the course promise to participants who complete the course jobs or placements?
  - No, the course does not offer placements nor promise jobs.
- 3. Can I practice arbitration or mediation after this diploma?
  - Yes, you can practice arbitration after you complete this program effectively.
  - The pre-condition is that the parties who are willing to resolve their dispute either through mediation or arbitration choose to appoint you as an arbitrator or mediator.
- 4. Can the trainee who successfully completes the PG-ADRM course be empanelled as Arbitrator on the ILSCA Panel of Arbitrators?

- Successful Completion of ILSCA PG-ADRM course acts as an entry pathway
  to the successful candidates for being considered to be on the ILSCA panel of
  arbitrators as junior arbitrators. Furthermore, the successful participants of this
  course will have an edge over others for being considered to be on the ILSCA
  panel of arbitrators. ILSCA Maintains two levels of Arbitrators-Senior and Junior
  arbitrators.
- ILSCA has a Qualifying Assessment Program (QAP) based on a precondition that the candidates need to complete certain pre-decided criteria of ILSCA to be eligible to be considered as junior arbitrator.

## **Evaluation of Arbitration Knowledge:**

- As per ILSCA QAP the applicant for being considered as junior arbitrator on the ILSCA Panel of Arbitrators - shall provide proof of having completed ILSCA PG-ADRM course.
- Such applicant will be assessed by ILSCA to evaluate his/her Arbitration Skills.: The evaluation of Arbitration skill will be based on assessment of an arbitral award submitted by the applicant, based on an assignment given by ILSCA.
- On evaluation of the assignment, the applicant should get a minimum of 55% score. On successful completion of the assessment such a person will be graded as **ILSCA Junior Arbitrator.**
- On failure to get the minimum score, the applicant will be able to apply under ILSCA QAP again, only after a period of 3 months.
- **ILSCA Junior Arbitrator** has a monetary limit of conducting arbitrations where the amount does not exceeding Rs.1 crore.
- A Junior Arbitrator, who has completed ILSCA **PG-ADRM** course with the topup program and after completing fifteen arbitrations as an arbitrator – singly or jointly is eligible to apply for accreditation as ILSCA Senior Arbitrator.

# 5. When do applications for the PG -ADRM open and what is the deadline for applying?

- The admission for the course will be announced on 28<sup>th</sup> September 2024.
- The admission notice will be released on the ILS website http://ilslaw.edu
- The last date for filling out the application forms for the diploma course is 10<sup>th</sup> October 2024

#### 6. What is the duration of the Course?

• The duration of the course is six (6) months. - 10<sup>th</sup> October 2024 to 10<sup>th</sup> April 2025.

### 7. Whether the course is correspondence course or classroom mode?

• PG Diploma in Alternative Dispute Resolution Methods is conducted by ILSCA in an online mode – The larger part of the program consists of self-study where

the study material is sent to the student and the student must study and learn on their own.

• In addition, there will be online classes conducted on the various topics of the course at intervals by experts on topics that are part of the program.

## 8. Whether contact classes will be on weekdays or weekends?

All our resource persons are professionals. It depends upon their availability as
well. We endeavour to schedule classes on the weekends. However, sometimes
due to faculties availability, we may also schedule a session on weekdays. But in
such cases, classes will be scheduled only in the evening, and prior notice will be
given.

#### 9. How are the classes conducted?

- Classes will be conducted online, preferably on weekends. The participants will log in through Google meet or ZOOM Meeting.
- The students will need to keep their cameras on throughout the online classes.
- Classes are mostly interactive.
- The timings of the sessions, the topic on which the session will be conducted, and the resource person details, will be shared in advance.

## 10. Whether attendance for contact classes compulsory?

• Yes, attendance for contact classes is compulsory.

#### 11. Fees for the course – inclusive of Reading Material

• Rs. 42,373/-+ Rs. 7,627 (18 % GST) = Rs.50,000/-

## 13. Will reading material will be provided?

 Reading material will be provided offline (Hard Copies) and online from time to time.

#### 14. Where will be the assessment pattern?

The final assessment of the student is done which is based on the following factors: Marks will be allotted to each of the following criteria.

• Attendance for the contact classes

- Project Submission (participants can choose any topic from the list of topics provided to them)
- Final examination (Online) at the end of the course

## 15. Are recent graduates eligible to apply for the course?

• Yes, recent graduates are eligible to apply for the course.

## 16. What documents are to be submitted at the time of Admission?

Candidates selected for admission are required to produce the following documents: (scan copies and submit them online)

- 1. Passing Certificate of the qualifying Examination
- 2. Statement of marks of the qualifying Examination
- 3. One passport-size photograph

## 17. What is the procedure for cancellation of admissions and refund if any?

• The candidate who intends to withdraw their admission must apply expressing his/her inability to continue with the course with valid reasons. The chart for refunding the fees on withdrawal of admission is as under:

On Cancellation of Admission		Fees to be refunded
•	Within 8 days of admission	80 % of total Fees
•	9 to 15 days of admission	50 % of total Fees
•	After 15 days of admission	No refund

**P.S.** - Fees once paid will not be adjusted to the subsequent course, under any circumstances, after the commencement of the course for which the fees are paid.
