Title: Broad Spectrum of Environmental Law

Report: This session delved into the intricate landscape of environmental law, exploring its significance in today's world and the role it plays in shaping environmental policies and practices. Beginning with a general introduction and overview of legislations such as The National Green Tribunal Act, 2010, The Air (Prevention and Control of Pollution) Act, 1981 & The Water (Prevention & Control of Pollution) Act, 1974, significant cases such as Salman Khan's Chinkaracase, Bhopal Gas Tragedy & M.C. Mehta v. Union of India (Ganga pollution case), Samir Mehta v. Union of India were also discussed. The session also constituted a comparative analysis of various initiatives taken by countries like Singapore, Indonesia & India at National & International level along with the role of international bodies relating to environment conservation, their goals. The session ended with an engaging Q&A interaction regarding general issues in environmental laws.

Title: Green Dispute Resolution in India

Report: This session threw light on the emergence of environmental disputes and the need for their resolution to protect sustainable development. To fulfil this need, India has established the National Green Tribunal (NGT) by passing the National Green Tribunal Act, 2010. The session went on to discuss the impact, shortcomings and relevance of the NGT in today's world. It also spoke about some of its significant judgments such as Ms. Betty C. Alvares v. The State of Goa and Ors., Almitra H. Patel and Ors. v. Union of India and Ors., and Samit Metha v. Union of India and Ors. The session concluded by discussing the need for speedy redressals in matters of environment.

Title: Prevention of Cruelty on Animals Act 1960 and Impact of Other Legal Fields on Animal welfare
