Report

The 9th ILS Intra-College Client Counseling Competition was conducted online, on the platform Google Meet due to the COVID 19 pandemic. The competition was conducted online in three rounds on 29 September 2021 (Preliminary rounds), 30 September 2021 (Semi-Final Rounds) and 1 October, 2021 (Final Rounds). Total 24 teams participated in the competition. The Schedule and Rulebook of the competition were released on 1 September, 2021.

Orientation and Demonstration:

The Orientation and Demonstration for the competition was held on 8 September, 2021. A Demonstration session was conducted by a team of Shivangi Maheshwari (IV BA.LL.B), Dristi Agarwal (all IV BA.LL.B) and Yash Jain (III BA LLB) who acted as the client. This was judged by Mr. Harshwardhan Salgaonkar, a practicing Advocate at the Bombay High Court who provided feedback and insights regarding the Demonstration and enlightened the attendees with the intricacies of client consultation.

An orientation session for the Clients was conducted on 9 September, 2021 where members of the Organising Committee explained the role of Clients and the manner in which the competition would function to the attendees.

The registration for the competition, for both the counsel teams and the clients took place on 13 September 2021.

Preliminary Rounds:

The Preliminary round was conducted on 29 September 2021 with 24 teams in 6 chambers each containing 4 teams. The chambers were links to 6 different Google Meet links where the judges,

The exercise of mooting is one of the highlights of every law curriculum. It teaches students the skills, quintessential for solving legal problems. These skills encompass both soft skills as well as writing skills. It is one of the apparent collaterals of any law school's curriculum and one which is most relished by most students.

ILS Moot Court Society ("MCS") was founded in the academic year 2014-15 to burgeon the interests of students in the activity of mooting, facilitate students to understand intricacies of legal research, acquire sufficient stronghold over the utilization of online legal databases, organize research to crisp and clear legal propositions on the issues presented in a moot proposition which finally culminates in to a clinching argument in a moot court competition. This is achieved with our student members hosting weekly sessions throughout the academic year on various aspects of mooting which range from introduction to mooting, use of research operators, tenets of legal reading and research, interpretation of statutes, moot demonstrations, drafting moot problems, drafting memorandums, formatting memorandums and mechanics of oral advocacy. In addition, MCS organizes the Novice Moot Court Competition and Public International Law Moot Court Competition to assist students in their first and sophomore year of law school to acquaint them with the exercise of mooting.

Every year, MCS also hosts Raghavendra Phadnis Moot Court Competition, which serves as a selection round for students inclined to represent ILS Law College at national and state level moot court competitions while Intra College Public International Law Moots Selection Rounds serve as a selection round for students inclined to represent ILS Law College at international moot court competitions or in moot court competitions where the subject matter is public international law. Both these competitions are highly awaited events of the year and witness massive participation from students across all batches.

Furthermore, MCS deals with all specific and ancillary aspects of organization of moot court competitions, circulation of invitations of national and international moot court competitions, client counseling competitions, mediation and negotiation competitions, trial advocacy competitions, allotment of the teams and assistance to students in completing respective registration processes of competitions.

The ILS Moot Court Society consists of student members from every batch who are selected every year based on defined criteria by inviting applications and conducting interviews. Once the core committee is formulated, the tasks at hand are democratically distributed within the members of the committee.

RAGHAVENDRA PHADNIS MOOT COURT COMPETITION

Due to the nation-wide lockdown imposed due to the outbreak of Covid-19, the 2021 edition of the Annual Raghavendra Phadnis Moot Court Competition was conducted virtually. Even though this posed unique and unprecedented challenges, the long-standing tradition of ILS Law College was continued and the competition was conducted successfully.

The Preliminary round of the Competition was conducted on 4 September, 2021. The Semi-Final and Final Rounds were conducted on 11 and 12 September, 2021 respectively. All the rounds of the Competition were conducted via Google Meet.

The Competition was coordinated by Dr. Deepa Paturkar, Faculty Coordinator ILS Moot Court Society and organized by Ashok Pandey, Priyanka Limaye, Yamini Jain, Iha Krishna, Neha Dhavalikar (all V BA LL. B), Anoushka Gahilot and Saee Hingmire (IV BA LL. B)

Preliminary Round

The preliminary round of the Competition saw participation of 332 students despite the virtual mode of participation. The participants were divided into 29 Courtrooms which were divided into morning and afternoon sessions. The Courtrooms were overseen by Courtroom Facilitators who played a key role in the successful conclusion of the competition. The Competition was adjudicated by 45 ILS Alumni who were experts in their respective subject matter.

The Moot Propositions for the 2021 edition were on four subject matters, i.e.,

- Arbitration Law drafted by Mr. Ritvik Kulkarni (Batch of 2017);
- Commercial Law drafted by Ms. Alefiyah Shipchandler (Batch of 2019);
- Criminal Law drafted by Ms. Oorjasvi Goswami (Batch of 2018); and
- Public International Law drafted by Ms. Divya Mittal and Mr. Rohit Bokil.

An Equity and Accessibility Committee was also set up to address the issues of students who were facing technical issues or did not have adequate access to technology. The role of the Committee was in charge of resolving the network issues faced by such students and making the Competition accessible to everyone. The Committee came up with a policy to ensure equity in the Competition and allowed participants with no access to smartphones, laptops or internet connection to join in via voice calls.

Semi-Final Round

After the highly competitive preliminary rounds, 55 participants qualified to the Semi-Final Round. The Participants had to argue a different Moot Proposition for the Semi-Final Round and the same proposition was to be argued in the Final Round. The Proposition was drafted by Mr. Amit Pai on Constitutional Law.

The Semi-Final Round was adjudicated by alumni as well as faculty members. The alumni judges for the Semi-Final Round were Mr. Tarun Srikanth, Ms. Sangeetha Ganesh, Ms. Varsha Ramann, Ms. Sukanya Sehgal and Ms. Parvathy Tharamel. The faculty members who adjudicated the Semi-Final round were, Adv. Prafulla Lele, Dr. Varsha Khandagale, Prof. Divya Mittal, Dr. Banu Vasudevan and Dr. Swatee Yogessh.

ANNUAL INTRA-COLLEGE NOVICE MOOT COURT COMPETITION

About the Competition:-

The Intra-College Novice Moot Court Competition is an Annual Moot Court Competition that is conducted with the motive of introducing the First Year B.A.LL.B and LL.B students to the practice of mooting. Through this competition, we aim to develop the students' interest in mooting and help them polish their legal research and oratory skills.

Eligibility: The Annual Intra-College Novice Moot Court Competition 2022 was open for participation by students in the First Year of B.A.LL.B and LL.B at ILS Law College, Pune.

Structure and Dates of the Competition:

The competition was conducted in three rounds viz. Preliminary Round (6 May 2022) Semi-Final Round (7 May 2022) and the Final Round (14 May 2022).

Cases for the Competition:

Participants were given the option to choose one among the following four moot propositions released on 23 April 2022 for the preliminary round based on different areas of law:

1. Law of Torts drafted by Neha Dhavalikar (V BA LL.B) and Keyur Jaju (III BA LL.B);

- 2. Law of Contracts drafted by Mihir Govande and Anoushka Gahilot (both IV BA LL.B);
- 3. Constitutional Law drafted by Sahaja Burde and Rashmi Birmole (both V BA LL.B); and
- 4. Public International Law drafted by Ashutosh Ghag (IV BA LL.B) and Ms. Shweta Shukla (III BA LL.B), with contributions from Mihir Govande (IV BA LL.B).

The same cases and same sides, as chosen by the participants, were carried on for the semi-final round. For the final round, a new case based on Arbitration Law drafted by Ms. Ishwari Pendse was released and the finalists were assigned their sides at random by the Organizing Committee.

Number of Participants and Judges:

I. Preliminary Round-

In the Preliminary Round of the Competition, a total of 167 students participated who were divided between 17 Courtrooms. Each courtroom was assigned two judges from V BA LL.B and III LL.B, who presided over the Round and provided valuable personal feedback to the participants. Each courtroom had one court clerk who kept tabs of the entry of participants as well as the time taken per participant.

The preliminary round saw enthusiastic participation from the first year as well as the final year students.

II. Semi-Final Round-

Upon the completion of the Preliminary Round, the top two scorers in each courtroom qualified for the Semi-Final Round of the Competition. A total of 34 semi-finalists were divided between 4 courtrooms. Each Courtroom had two esteemed Judges, who were learned persons from the field of law, either practicing or professing the subject.

III. Final Round-

Upon the completion of the Semi-Final Round, the top two scorers in every courtroom qualified for the Final Round of the Competition. There were a total of 8 finalists arguing the same case in a single courtroom. The Final Round was judged by 3 esteemed judges — Dr. Tejaswini Malegaonkar, Dr. Swatee Yogessh and Ms. Ishwari Pendse. The top three scorers were declared as the Winner, the First runner-up and the Second runner-up:

11th ILS INTRA-COLLEGE TRIAL ADVOCACY COMPETITION

The 11th ILS Trial Advocacy Competition, 2021-22 was held virtually on 29, 31 January and 5 February 2022 being the Preliminary Round, Semi-final Round and Final Round of the Competition, respectively. The problem was based on the Indian Penal Code, Maharashtra Control of Organised Crime Act, 1999, and Transplantation of Human Organs and Tissues Act, 1994. The Problem incorporated issues relating to murder, organ commercialization and also criminal conspiracy. It further incorporated novel aspects of organized crime syndicates, toxicology and Voice Spectrograph Analysis.

The problem was drafted by the Organising Committee consisting of Dipti Deshpande, Mihir Beradia, Nikita Garge, Aakanksha Ranjan, Harinoor Jham, and Varad Partani with assistance from Rohan Marathe, Dayita Panicker, Saloni Dhumal, Sarab Lamba. Further Gunjan Suyal, Anushka Tasgaonkar, Shraddha Bhide and Siddhant Chabbra were recruited as new members for this year's edition who helped with the organization and management of the competition. The organizing committee also conducted a Demo Trial on the previous year's problem to acquaint the students with the concept and procedure of a criminal trial. The competition received an overwhelming response from the student participants. A total of 24 teams registered comprising 96 participants. 4th ILS INTRA COLLEGE MEDIATION COMPETITION, 2021 IN ASSOCIATION WITH ILSCA

Faculty Coordinator: Ms. Sathya Narayan.

Details of the Competition: The 4th ILS Intra College Mediation Competition was held on 9-10 October, 2021, with a total 108 participants. The competition was organized in association with the ILS Centre for Arbitration and Mediation for the fourth consecutive year. This Competition aimed to educate the young and fresh students who have entered the law stream about mediation as an alternative dispute resolution mechanism.

Four distinct problem propositions were drafted for the competition, with two problem propositions for the preliminary rounds, and one problem proposition for the semi-final and final rounds each. These problem propositions aimed at showcasing the role of mediation in disputes ranging from inter-state agreements to tenancy problems and commercial and celebrity agreements. The Competition introduced and educated the students about mediation as an alternative dispute resolution mechanism.

Problem Propositions for the Competition: Four distinct problem propositions were drafted for the competition, with two problem propositions for the preliminary rounds, and one problem proposition for the semi-final and one for the final round. These problem propositions aimed at showcasing the role of mediation in disputes ranging from inter-state agreements to tenancy problems and commercial and celebrity agreements.

Both the problems for the preliminary rounds involved public disputes in the entertainment industry. One of the problems involved a dispute between a record label and its estranged artist, and the streaming and promotion of musical soundtracks. The second problem for the preliminary rounds revolved around couples in the entertainment industry and their dispute with a popular magazine which hired a wedding photographer.

The problems were randomly assigned to the participants and a total of 36 participating teams, including a Client-Attorney pair and an independent mediator, participated in the preliminary rounds held on 9 October, 2021. Further, one team from each conference room, i.e. 6 teams qualified for the semi final rounds held on 10 October, 2021. The problem for the semi-final rounds was inspired by the Russian Doping Scandal in the Tokyo Olympics, and focusing on the need of achieving peace between a country and the International Olympic Committee and involved issues

of international relations. Out of the 6 teams, 2 teams qualified for the final rounds held on the same day.

The problem for the final rounds was based on the current dispute between the designer Sabyasachi Mukherjee and the Dastakari Haath Samiti. The problem dealt with mediation involving commercial contracts in the field of design and apparel and the round was judged by Ms. Anupama Ahluwaia, an advocate and an accredited mediator in the United States of America and India and is empanelled as a mediator with the Supreme Court of India; Ms. Krishna Thacker, Founder and Managing Partner at M.T. Thacker and Associates, and an accredited mediator with IIAM; and, Mr. Prathamesh Popat, founder of the Professional Resolutionary, Academic & Conflict handling Initiatives Mediation Chambers.

All of the problems were very well received by the participants as well as the judges of the competition. The competition witnessed overwhelming enthusiasm and participation of the students of the college in understanding the techniques of mediations as a method of alternative dispute resolution, making it a huge success.

The 108 participants were further divided into 36 participating teams, consisting of a Client-Attorney pair and an independent mediator. The 36 teams participated in the preliminary round held on 9 October 2021. One of the problems for the preliminary was based on contractual issues between the music entertainment company and music band. The second problem for the preliminary rounds was based on a contractual dispute between an event management company and their clients.

Out of these 36 teams one team from each courtroom, i.e. 6 teams qualified for the semi-final round which was held on 10 October 2021. The problem for the semi-final round was based on a dispute between an international sports organization and a member country, focusing on the need of achieving peace between the two parties.

Out of the 6 teams, 2 teams qualified for the final rounds held on the same day. The problem for the final rounds was based on a labor dispute between a fashion house and its workers.

The problem propositions for the competition were drafted by the Organising Committee consisting of Sneha Kulkarni, Onjula Chatterjee, Nirali Hamirwasia (all V BA LL.B.); Ashbi George Aryapurath (III LL.B.); and Arundhati Patkar, Titiksha Narkhede (IV BA LL.B.), Pratyusha Susarla, Sanika Paithankar, Manva Khojare (III BA LL.B.). PROFESSOR S. P. SATHE 15th NATIONAL MEMORIAL MOOT COURT COMPETITION

Remembering S P Sathe:

Professor S. P. Sathe Foundation, set up by the Indian Law Society, organizes "Remembering S P Sathe" event that consists of Public Memorial Lecture, Moot Court Competition, and Conference at ILS Law College, Pune on a specific theme with a view to commemorate his contribution to Indian Jurisprudence and Social Action and to encourage academic pursuit of law students. This annual event of 2020-21 was delayed due to the pandemic and was held in October 2021 in a virtual mode.

Theme of the Moot Court Competition:

The theme of this year's (2020-21) moot proposition was 'Role of Forensic Science and Technology in Criminal Justice System: Challenges and Threats'.

Technological revolution has brought a paradigm shift in the fields of forensic science. DNA profiling, lie detector tests, narco analysis are some of the most obvious and striking examples of such a merger of scientific discovery, technological advancement and forensic application in the criminal justice delivery system. There is an increased resort to the application of new technological advancements in forensic science to criminal investigation. The benefits are many folds; but primarily it has the potential to strongly increase the speed and efficacy of criminal investigation. While on the other hand the application of forensic tools has led to moral, legal and physical abuse of individuals. Use of forensic tools in the criminal justice system raises serious issues of privacy rights and violation of human rights.

Essentially forensic science has to operate in a legal context. There are constitutional and other legal constraints on how a criminal investigation can be carried out. It also raises concerns about reliability and relevance of scientific evidence in criminal trials. Therefore it is necessary to set out the rules regarding validity, reliability, admissibility and acceptability of scientific and digital evidence in criminal trials.

Report:

This year the competition saw the registration of eight teams from India. They were namely, National Law Institute University, Bhopal, Dharmashastra National Law University, Jabalpur, Symbiosis Law School, NOIDA, School of Law, SASTRA Deemed to be University, Thanjavur, ILS Law College, Symbiosis Law School, Pune, Maharashtra, Maharashtra National Law University, Nagpur and School of Law, Christ (Deemed to be University.)

The competition was conducted in two rounds namely, preliminary round and final round. The preliminary round was conducted on 23 October, 2021 and the final round was conducted on 24 October, 2021.

"REMEMBERING SP SATHE"

PROFESSOR S. P. SATHE 16TH INTERNATIONAL MOOT COURT COMPETITION 2022 (VIRTUAL)

Considering the recent increase in environmental conflicts mainly due to climate change at the international frontier, it is pertinent to have a discourse amongst law students on the relevant issues. The Professor S.P. Sathe 16th International Moot Court Competition was organized to introduce participants to the intersection of International Law with Climate Change. International cooperation is essential to the effort against climate change and the need for which was visible at CoP 26 at Glasgow. Therefore, it is important to comprehend and recognize the role played by international law in facilitating this cooperation, and enabling adaptation efforts across the globe.

Climate refugees are people whose lives and livelihood are endangered due to climate change, because of their geographical circumstances. Currently, the international law is inadequate to recognize the needs of climate refugees and provide redressal for their loss and damages suffered due to the actions of climate polluters. The effects of climate change are becoming deeply intertwined with the socio-economic fabric of our society, and it is imperative that international law develops to accommodate this new reality. Through this moot we aimed to equip the students with the understanding of the nuances of international law, climate law, and humanitarian law, particularly when it comes to dealing with conflicting interests of state and non-state actors as regards the welfare of the people. The moot proposition was drafted by Ms. Divya Mittal and Mr. Rohit Bokil, Assistant Professors at ILS Law College. The Moot Court Competition received a grant of Rs 30,000/- from the Savitribai Phule Pune University. The knowledge partners for the Competition were SCC Online and EBC.

A total number of 28 teams participated in the Competition from across India. The competition was divided into four rounds, namely, preliminary, quarter finals, semi finals and the final round.
