More than 150 students represented ILS Law College as speakers, researchers and participants in 26 Moot Court Competitions, 4 Trial Advocacy Competitions, 3 Client Counseling Competitions, 1 Negotiation Competition, and 9 Mediation Competitions. Structure of the Competition: The 12th Judgment writing competition was organized on 11th January 2020 at the ILS Law College; in the memory of Judge Shri. P.N. Behere, a former District and Sessions Judge of Pune, and President of the Pune District Consumer Forum.

The Competition was open for the students from the last two years of BA LL. B and LL.B. courses and for LL.M. students. 31 Students participated in the competition. Teachers and other students witnessed the proceedings.

Hon'ble Justice Girish Kulkarni, Judge Bombay High Court was the Chief Guest. He inaugurated the Competition, presided over the proceedings as a judge (Ombudsman) and guided the students. Shri. Nitin Deshpande, Advocate presented arguments for the Complainant. Shri. Rishikesh Ganu, Advocate presented argument for the Respondent.

The case for the competition this year related to a claim before Insurance Ombudsman. The brief consisting of Complaint, reply by Insurance Company, documents and correspondence was circulated to participants four days before the Competition. The brief was based on imaginary facts. It was drafted by Rajalaxmi Joshi and Dr. Nilima Bhadbhade, faculty at ILS Law College, Pune.

Justice Dr. Shalini Phansalkar Joshi (Retired Judge Bombay High Court) was present throughout the competition and assessed the judgments. She also expressed her views and guided the students as to how to write a judgment.

10TH ILS INTRA COLLEGE TRIAL ADVOCACY COMPETITION, 2019-20

Structure of the Competion: The 10th ILS Trial Advocacy Competition 2019 was held on 5th, 7th and 12nd October 2019. The problem was based on Law of Crimes, The Black Magic Act 2013 and The Information Technology Act 2000.The Problem incorporated issues relating to abetment to suicide, hacking, and also criminal intimidation. It further also showed novel aspects of online bullying and mental postmortem.

Problem proposition and demo: The problem was drafted by the Organising Committee consisting of Rohan Marathe, Dayita Panicker, Saloni Dhumal Sarab Lamba, Dipti Deshpande, Mihir Beradia and Nikita Garge. An administrative committee of 8 students helped in organising the event. The organising committee with the help of the previous years' winners and runners up also conducted a Demo Trial on the previous year's problem to acquaint the students with the concept and procedure of a criminal trial. The competition received an overwhelming response from the student participants. A total of 48 teams registered comprising of 192 participants. Moreover around 168 students participated as witnesses, who induced life into the various characters involved in the problem. The event which was successfully organised saw the cumulative participation of more than 360 students as participants and witnesses.

Rounds: The preliminary round was conducted on 5th October 2019 which was judged by various practicing advocates from the session's court of Pune and Mumbai. One team from each courtroom i.e. a total of 8 teams qualified to the semi-final rounds which were held on 7th October 2019 and further 2 teams qualified to the final round held on 12nd October 2019. The final round was judged by a bench consisting of Advocate Hassnain Kazi, Advocate Ankita Sarkar, Advocate Shakul Ghatole, and Advocate Charuhas Dharmadhikari. Off the four judges three were previous members of the Trial Advocacy Committee of ILS from its initial years and the developments introduced in the format of conducting a trial-based competition were highly appreciated by them.

Structure of the Competition: The 7th ILS Intra-College Client Counselling Competition was conducted in 2 rounds on 23rd& 24th August 2018. A total of 24 teams participated in the preliminary rounds.

Orientation and Demonstration: The orientation and demonstration for the competition was held on 20th of July, 2018. A comprehensive orientation was given by Mrs. Preeti Sukhtankar (Lawyer and ILS Alumni). A demo session was conducted by a team of Aishwarya Dixit (V BA LLB), Rajmohan CV (V BA LLB) and Anoop George (V BA LLB) who acted as the client. This was judged by Preeti Sukhtankar who also went on to provide needful insight and enlightened us with the intricacies of client consultation. A clarification session was also followed by the demonstration.

The Preliminary Round: The preliminary round was on the 23rd of August among 24 teams in 6 chambers each containing 4 teams. 6 sets of problems were drafted for each chamber based of Family law, Contract Law, Intellectual Property and Labour Laws. These cases were drafted by the Organising committee members – Atharv Joshi (IV BA LLB), Aishwarya Dixit (V BA LLB), Maitri Asher (III LLB), Huzan Bhumgara (III LLB) Sanjeevani Mehrotra (IV BA LLB), and Vivek Sharma (IV BA LLB). A total of 6 teams, one from each chamber were selected for the semi-final rounds.

Semi-Final Rounds: 6 teams reached the semi-final rounds which were held on 24th August. There were two chambers comprising of three teams each. The cases were based on Law of Crimes with emphasis on Criminal Procedure Code and were drafted by Senior Organising Committee members Atharv Joshi (IV BA LLB) and Rajmoan CV (V BA LLB). One team from each chamber was selected for the Finals. The semi-finals were judged by Adv. Aditya Kanetakar, Adv Aarti Bhonsle, Adv. Pushkar Patil, Adv. Akash Katawati.

Final Rounds: The final rounds of the 7thILS Intra College Client Counselling Competetion was held on 24th August. 2 teams were selected for the final rounds, Tapan Radkar (IV BA LLB) & Jay Kakani (IV BA LLB) and Anshika Sharma (IV BA LLB) & Shreya Sukhtankar (IV BA LLB). 2nd ILS INTRA COLLEGE MEDIATION COMPETITION IN ASSOCIATION WITH ILSCA, 2019-20

Details of the Competition: The 2nd ILS Intra College Mediation Competition was held on 7th and 8th September, 2019, with a total 192 participants. The competition, in its second year, was organised in association with the newly established ILS Centre for Arbitration and Mediation. Three distinct problem propositions were drafted for the competition, which showcased the role of mediation in disputes ranging from inter-state agreements to familial problems and commercial agreements. The Competition introduced and educated the students about mediation as an alternative dispute resolution mechanism. The problem for the preliminary was inspired from the concepts of Carbon Trading and its impact on the inter-state relations. A total of 64 participating teams, including a Client-Attorney pair and an independent mediator, participated in the preliminary rounds held on 7th September 2019. Further, two teams from each courtroom, i.e. 16 teams qualified for the semi final rounds held on 8th September 2019. The problem for the semi final rounds was based on disputes of two neighbours, focusing on the need of achieving peace between the two parties. Out of the 16 teams, 4 teams qualified for the final rounds held on the same day. The problem for the final rounds was derived from agreements between race car drivers and the companies that hire them for world championships. The problem dealt with mediation involving commercial contracts and the round was judged by Mrs. Gandha Sahu, the co-founder of the Council of Mediators and Arbitrators and Mr. Prathamesh Popat, founder of the Professional Resolutionary, Academic and Conflict handling Initiatives Mediation Chambers.

Problem proposition and Organising Committee: The problems for the competition were drafted by the Organising Committee consisting of

The exercise of mooting is one of the highlights of every law curriculum. It teaches students skills quintessential for solving legal problems. These skills encompass both soft skills as well as writing skills. It is one of the appurtenant collateral of any law school's curriculum and one which is most relished by most students.

The ILS Moot Court Society ("MCS") was founded in the academic year 2014-15 to burgeon the interests of students in the activity of mooting, facilitate students to understand intricacies of legal research, acquire sufficient stronghold over the utilization of online legal databases, organize research to crisp and clear legal propositions on the issues presented in a moot proposition which finally culminates in to a clinching argument in a moot court competition. This is achieved with our student members hosting weekly sessions throughout the academic year on various aspects of mooting which range from introduction to mooting, use of research operators, tenets of legal reading and research, interpretation of statutes, moot demonstrations, drafting moot problems, drafting memorandums, formatting memorandums and mechanics of oral advocacy. In addition, MCS organizes the Novice Moot Court Competition and Public International Law Moot Court Competition to assist students in their first and sophomore year of law school to acquaint them with the exercise of mooting.

Every year, MCS also hosts Raghavendra Phadnis Moot Court Competition, which serves as a selection round for students inclined to represent ILS Law College at national and state level moot court competitions while Intra College Public International Law Moots Selection Rounds serve as a selection round for students inclined to represent ILS Law College at international moot court competitions or in moot court competitions where the subject matter is public international law. Both these competitions are highly awaited events of the year and witness massive participation from students across all batches.

Furthermore, MCS deals with all specific and ancillary aspects of organization of moot court competitions, circulation of invitations of national and international moot court competitions, client counseling competitions, mediation and negotiation competitions, trial advocacy competitions, allotment of the teams and assistance to students in completing respective registration processes of competitions.

The ILS Moot Court Society consists of student members from every batch who are selected every year based on defined criteria by inviting applications and conduct of interviews. Once the core

committee is formulated, the tasks at hand are democratically distributed within the members of the committee.

RAGHAVENDRA PHADNIS MOOT COURT COMPETITION

Faculty Co-ordinator: Dr. Deepa Paturkar

Raghavendra Phadnis Moot Court Competition is an annual Intra College Competition held to foster a spirit of mooting among students and also serves as a selection round for National Level Moot Court Competitions. Students from the Second year to Final year of the Five-year Integrated Law Course and Second year to Final year of the Three Year Post Graduate Law Course are eligible to participate. The Moot Court Society conducted an orientation on the basics of mooting and a session on memorandum drafting for the benefit of the students.

Format of the competition: The Competition witnessed a change in format this year. It was held in three rounds of preliminary, semi-finals and finals on 27th July, 10th August and 11th August respectively. Unlike previous years, the students qualifying for the semi-final rounds had to argue a new problem and also submit a memorandum. Moreover, the semi-final rounds were conducted with students being pitted against each other as matchups. These changes were introduced in order to familiarise students with the mooting process in inter-college competitions. This year's edition witnessed the participation of 400 students arguing the preliminary rounds in 28 court rooms.

Rounds: Participants for the preliminary rounds were given an option to choose one among the 4 cases in relation to

- 1. Public International Law by Ms. Janhavi Pande
- 2. Commercial Laws by Mr. Zacarias Joseph
- 3. Law of Crimes by Ms. Senjuti Mallick
- 4. Law of Consumer Protection by Mr. Satish Rai and Mr. Aayush Mitruka

The drafters of the problem had attached an elaborate orientation note along with their respective moot propositions to aid the students in research. The preliminary rounds were judged by esteemed ILS alumni.

The first two rankers from each court room from the preliminary rounds qualified to the semi-final rounds held on 10th August 2019.

The semi- finals and finals case was drafted by Mr. Sharath Chandran, an alumnus of ILS Law College and University of Oxford. The case was based on law of constitution and administrative law. 56 students argued in the semi-final rounds in 5 different court rooms. The rounds were judged by 10 judges, including academicians and practicing advocates.

After relentless and gruelling rounds, 10 students qualified to the final rounds. The students argued the same case for the final round. The round was judged by the drafter himself along with Mr. Krishna Mohan, an alumnus of ILS Law College and a practising advocate at the Supreme Court of India and Mr. Kedar Kanetkar, an alumnus of ILS Law College and an advocate at the High Court of Bombay.

Mr. Tapan Radkar, a student of IV BA LLB emerged as the winner of the competition while Mr. Nauman Beig and Ms. Sakshi Kapadia, students of III BA LLB were adjudged as runner up and second runner up respectively.

ONLINE PRACTICE MOOT

Online Practice Moot 2020 was conducted by the ILS Moot Court Society to introduce students to the activity of mooting and enable students to moot competitively in the future. In light of the COVID-19 nationwide lockdown; their integration into the mooting process in college was hampered. In order to remedy this situation, theonline practice moot was conducted as acocurricular non-competitive activity in which students from the first year of the Five-year Integrated Law Program and the Three Year Post Graduate Law Program participated.

The first edition of the activity was coordinated by Dr. Deepa Paturkar, Asst. Professor, ILS Law College, Prof. Varsha Khandagale and Prof. Pronema Bagchi.

Comprehensive and instructive online orientations were conducted by Mr. Satish Rai, Ms. Tanvi Mate, Ms. Shreya Kunwar Ms. Shishya Goyal, Ms. Jafreena Cassad and Ms. Sruthi Jayaprakash for the benefit of the students.

Due to the semester being cut short, the first-year students were able to attend college only for a few months. However, this did not deter the students from participating in large numbers and showcasing their mooting abilities. The students were provided remote access to the Online Research Databases such as Westlaw, Lexis Advance, SCC Online, Manupatra and Hein Online which enabled them to prepare for the moot. For the first time ever, the activity was conducted virtually on 7th May 2020 on Google Meet. 62 students from I BA LLB and I LLB participated in the activity. 13 virtual courtrooms consisting 4 to 5 participants each were created and the participants were given time slots in which they had to present their case before a panel of final year students. Students also submitted their compendiums to via email to the organisers before the moot and the same were sent to the judges. 26 students from V BA LLB and III LLB presided over the activity and provided valuable personal feedback to the participants. They were very supportive of the new format and helped ensure that this one-of-a-kind event was as success.
